I. JUDICIARY OF RWANDA

PROJECT PROPOSAL SUBMITTED TO THE KINGDOM OF THE NETHERLANDS

I. JUDICIARY OF RWANDA

1.2. BACKGROUND

During the 1994 Genocide against Tutsi, the Judiciary of Rwanda as other organs of State lost human resources, infrastructure and materials. From 1998, Rwanda initiated the process of reconstruction and reform of State organs and public institutions. The Judiciary was part of this process. The first reform of Judiciary was funded by The Kingdom of Netherlands. It proposed a new structure of courts in Rwanda. Laws were revised to accommodate the new structure. This reform was integrated in the 2003 Constitution that was revised in 2015.

To support this reform in the Judiciary, the first project called "Projet d'Appui aux Cours et Tribunaux, PACT1" financed by the Kingdom of Netherlands, helped the Judiciary to have adequate infrastructure and the following court buildings:

- GASABO Court House in Kigali City that is used by Gasabo Intermediate Court and Primary court of Gasabo and Prosecution offices;
- GICUMBI Court house in Northern Province that is used by Gicumbi Intermediate Court and Primary Court of Byumba and Prosecution offices;
- NYARUGENGE Court house in Kigali City that is used by Nyarugenge Intermediate Court and Prosecution offices;
- NGOMA Court house in Eastern Province that is used by Ngoma Intermediate court and Primary court of Kibungo and Prosecution offices.

The support received through PACT 1 also funded the continuous training of new Judges and registrars to make them conversant with new laws. It further provided basic court equipment and IT infrastructure. All higher courts were equipped with computers and printers while lower courts (Tribunaux de District et Ville) received one computer and one printer for each court. This project supported the elaboration of the first Judiciary Strategic Plan 2005-2007 and provided the transport equipment (13 vehicles) for all new High Court Chambers, Inspectorate of Courts and Intermediate courts.

At the completion of PACT 1, the judiciary had to tackle the remaining challenges mainly related to IT infrastructure, access to justice and administration of justice and strengthening independence of the Judiciary. To address these challenges, The Kingdom of the Netherlands provided an additional support which resulted in PACT 2 "Support project to the Rule of Law that started in 2007 and ended in 2011. Among the achievement of this project, it is worth mentioning the following:

- **Access to Justice:** tools of public awareness were developed, Jurisprudence and new laws compiled, published and disseminated.
- **Administration of justice:** Judicial staff training, acquisition of law books, setting up and furnishing law libraries in all courts.
- **IT infrastructure and introduction of court technologies**
- **Construction of new court houses, extension of small ones and rehabilitating old ones.**

Under PACT 2, the court houses which were constructed / rehabilitated include the following:

- MUSANZE courthouse that is used by Intermediate court of Musanze, commercial court of Musanze in Northern Province (construction).
- Four (4) New Primary Courts were built which include: Kagarama, Kacyiru, Mugombwa and Nyagatare Court (construction)
- Primary court houses of Ngarama and Gatumba (expansion)
- The Supreme Court and Commercial High Court buildings (rehabilitation)

In 2012 new challenges emerged notably the trial of genocide cases transferred to Rwanda by ICTR and foreign countries. A new project was therefore designed to address among other issues the following:

1. Technical and Legal Research support for Judges and Prosecutors
2. Modernisation and use of ICT in court processes and across the whole criminal chain.
3. Capacity building of witness and victim protection unit staff both in the National Prosecution Authority and the Judiciary
4. Training of judges and prosecutors in prosecuting and adjudicating international criminal cases
5. Physical infrastructure and logistical facilities for the High Court Chamber in Charge of international criminal cases
6. Capacity building of legal research and law reporters
7. Adequate support for the Genocide Fugitive Tracking unit

In order to handle these challenges, a third Project called "**Capacity Building of Judiciary and Prosecution for Extradited Suspects of the Genocide**" funded by the Kingdom of Netherlands was initiated and aimed at strengthening national capacities of the Rwandan judiciary and prosecution to deal with the trials of extradited suspects of the genocide in a manner that fully complies with all international and UN standards for fair trial.

The project had five components that addressed key areas of Rwandan Judiciary and Prosecution which include:

- **IT infrastructures;** the project equipped the Judiciary and NPPA with important IT equipment that included Desktop computers, Laptops, Terminal devices, Video conferencing system and Court room technologies.
- **Capacity Building and Knowledge sharing;** Based on partnership between the Judiciary, ILPD and ICTR, Six training sessions were conducted and were attended by Judges, Registrars, and Prosecutors in Matters related to handling international crimes. The number of trainees in each training sessions were between 35 and 53 participants for a period of three full days for each session.
- **Physical Infrastructure support;** The Nyanza Court house that accommodated the High Court Chamber of International Criminal Cases (HCCIC), High Court chamber of Nyanza and the primary court of Busasamana marks the realisation of the biggest component of this project and a major milestone in the strengthening the Judiciary and Prosecution in matters related to handling the International crimes. This building has facilities for witness protection, Lawyers, prosecutors and Judges and Registrars that are at the international standards.

- **Technical assistance;** through this project the Judiciary and Prosecution has recruited Expert Legal researchers, Legal advisors, Witness protection expert and Law reporting experts. These experts have facilitated Judges and Prosecutors in handling the transferred cases from ICTR and other cases of International crimes nature. For the first time the Judiciary has been able to publish its Law reports on a quarterly basis.
- **Support to the Genocide Fugitive Tracking Unit (GFTU);** the project has significantly supported the GFTU in field of investigations throughout the country and over one thousand files of Genocide suspects were investigated and data captured in the GFTU data base.

The Judiciary and Prosecution have greatly benefited from the support of the Kingdom of the Netherlands in their quest to build strong institutions that will continue to dispense quality and timely Justice. This was the result of smooth implementation of the above mentioned project which tremendously strengthened the Rwandan judiciary that we have today.

As a matter of fact, the support received from the Kingdom of the Netherlands, especially in the project of capacity building of Judiciary and Prosecution for Extradited Suspects of the Genocide has helped the High Court Chamber of International Crimes (HCIC) to deliver the verdicts on five extradited suspects of Genocide including, two (2) cases from ICTR and three (3) cases from other Countries from 2015. Furthermore, High Court Chamber of International Crimes has other four (4) cases of extradited genocide suspects that are still on-going under trial.

The HCCIC has also tried seven (7) Genocide cases from big personality suspects including high officials. One case is still on-going. All those cases have been handled with reference to the international standards for trying the International crimes which is obviously the tangible impact of capacity building support funded by Dutch project.

Recently Judiciary has received support from the following partners who support Judiciary development:

1. **USAID.** It is supporting Judiciary through the Ohio University which is providing training on judgement writing, and use of precedence for judges and Registrars of High Court, Court of Appeal and Supreme Court.

In addition to this, the USAID via DUTEZE IMBERE UBUTABERA Project will support Judiciary to:

- Train IECMS users,
- Support the implementation of a court performance management module.
- Implement a Law reporting module in IECMS which will be linked to the law reports and precedence system.
- Provide specialized training in economic and financial crimes and cybercrimes.
- Coordinate a judicial exchange programme focusing on the following topics:
 - Court management
 - Case management systems
 - Interaction between judges/judicial personnel and court users
 - Use of ICT in courts and the country's judicial system
 - The type, role and contribution of other courts/judiciary members
 - Application of and ensuring adherence to the code of ethics/conduct for judges and judicial personnel.

2. IDLO will train Judges and Registrars as follows:

- **From the Court of Appeal:** 13 judges, 13 registrars and 10 researchers
- **From the Court:** 1 judge
- **From the High court chamber for international crimes:** 6 judges and 6 registrars

This training will cover the following topics:

(i) Session 1: Substantive and Procedural International Criminal Law

- The substantive crimes: genocide, crimes against humanity, and war crimes, including SGBV crimes, and their constituent elements.
- Modes of responsibility
- Circumstances excluding responsibility
- Review of the Transfer Law procedure and its application
- An overview of international criminal procedure, and a comparative analysis with Rwandan procedure and application

(ii) Session 2: International Criminal Legal Research and Practice

- The impact of rights of the accused on the substantive and procedural aspects of trials, and on appeal
- Finding and navigating the major international criminal law databases
- How to find and search ICTR and MICT decisions, judgements, transcripts, and evidence
- Implementation of the Practice Direction on Investigations
- Application of the doctrine of stare decisis in international criminal trials

(iii) Session 3: Best Practices in the Effective Management of Trials and Appeals including Judgement-Drafting

- Evidence management and evidential matters in complex trials, including adducing ICTR/MICT evidence and judicial notice; cross-examination and objections;
- Witness protection and vulnerable witnesses
- Effective courtroom management and access to court records
- Principles of effective judgement drafting including the role of legal staff

1.3. REMAINING CHALLENGES

The Judiciary of Rwanda has a vision of providing timely and quality justice. Since the judicial reform of 2003, major efforts were put in to meet this vision. As of now, tangible results were achieved in terms of improved speed of processing cases and quality of judgments. However, the Judiciary still faces challenges in terms of quality judgments, mainly due to:

- Lack of sufficient specialized legal skills in different branches of law for judges, prosecutors and investigators;
- Persisting case backlogs in courts;

- Lack of adequate and easily accessible legal information to judges and prosecutors.

These challenges are analyzed in the following paragraphs.

Lack of sufficient specialized legal skills for judges

When Judiciary undertook the first major reform in 2003, it had 702 judges among them 84 only had a degree in law. The reform reduced the number of judges and kept only 288 judges. Those who had no degree in law were replaced by fresh young graduates in law studies.

After the reform of 2018, which increased the number of judges from 288 to 315, only 57 have completed short courses in 6 specialized branches of law among 8 branches¹ which Judiciary selected to make Judges more skilled and professional. In addition to this, only 43 have a Master's degree and 3 have PHD.

Apart from the 84 judges who were in judicial career prior to 2004 reform; the 204 judges were fresh graduates recruited in past 14 years meaning that the majority of judges have experience of 14 years. This shows the skills gap among judges which is a challenge to quality of judgment, a prerequisite of delivering quality judgment.

The following table shows the distribution of law qualifications among judges.

Relevant interventions will be identified in this project to contribute to the improvement of knowledge and skills of judicial staff.



1. Practical aspects of contract and tort,
2. International crimes and genocide ideology
3. Persons and family
4. Banking legal practice
5. Practical aspects of economic and financial crimes
6. Corporate law and insolvency
7. Criminal process and sentencing
8. Civil case management and judging

This Persisting cases backlog

A case which spends more than 6 months in a court is considered as backlog. By end of June 2018, the case backlog represents 25% of all cases in courts from 23% in June 2017 while they were 32% in June 2016. Having such big number of backlogs delays justice but also put more pressure on judges. When their workload is so heavy, it impacts the quality of judgment as they do not have sufficient time to analyze their cases.

The following graph shows the number of cases remaining in each court by end of June 2018².



The total number of pending cases was 24,783 representing 34% of judged cases during the same year. When compared to entering cases which were 63,360, the pending cases represents 39%.

This project will devise intervention which will help Judiciary to reduced case backlog in courts to the targeted level.

Lack of adequate and easily accessible legal information to judges and prosecutors to help them while analyzing and deciding on the cases.

Legal information is a tool used and referred to by judges during case analysis and decision. They are mainly laws, legal books and precedence judgments in form of law reports. All these resources are available in insufficient quantities, and not well organized to be accessed by judges. Laws are scattered, physical libraries have so few books, no access to online libraries.

With regard to law reporting, it was initiated from 2014 by third project funded by the Embassy of the Kingdom of Netherlands. At the end of the project, Judiciary has recruited three permanent law reporting staff while there were 8 during the project phase.

Unavailability of adequate legal information impacts negatively the quality of judgment, delays the decision making and once the decision is not well supported with well searched legal information, the litigants become less convinced by the decision, appeals the cases thus increasing the number of cases in courts.

This project will contribute to generation and organization of legal information to support judges to increase not only their knowledge but also the reduction of time used to search for adequate information during case processing.

1.4. PROJECT IMPACT, OBJECTIVES (OUTCOMES), RESULTS (OUTPUTS), ACTIVITIES AND RESOURCES

1.4.1. Project impact: improved quality of judgments

The expected impact of this project is the improved quality of judgments expressed in terms of its predictability and consistency. The quality of judgment is measured by the rate of cases overturned at appeal level and the confidence of citizens in decisions of courts, timely judgment, and transparency of court proceedings as well as fairness of court decisions.

The rate of overturned cases which stand at 8% by June 2018 shows the consistency and predictability mainly for litigants. It shows the level of convergence of judges in lower courts and appeal in analyzing the facts of cases and determination of court decision.

This rate stands as follow by court level:

- Intermediate courts: 7%
- High Court: 7%
- Commercial High Court: 28%
- Supreme Court: 14%

In order to achieve the desired impact, this project will pursue the following outcomes:

- Legal Knowledge and Skills of judges improved
- Cases Backlog reduced
- Adequate and easily accessible legal information to judges and prosecutors provided.

The impact of this project will be improvements of quality of judgment in terms of judgment predictability and consistency. This will serve as one of means of crime deterrence, reduction of litigations, reducing the number of cases in courts, increase the confidence of citizens who trust fairness of court decisions which stands (currently at 85.80% according to Rwanda Governance Board Score card report of 2018), making Rwanda a more peaceful society, the time and resources that citizen and Government allocate to settlement of litigations and managing crimes and offences will be injected in productive activities and ultimately contributing to the development of Rwanda.

1.4.2 Outcome 1: Improved legal knowledge and skills for judges

The analysis of case and determination of court decisions relies on the knowledge, skills, experience and the ethical stands of a judge. The majority of judges are young generation who entered in judicial career during the 2003 reform at the end of their university studies with good general knowledge in legal domain but lacking the practices and specialized skills.

Currently, the specialized legal skills are still lacking. Only 3 judges have PHD, 39 Master's degree in law, 271 Bachelor's. In order to cope with this challenge, Judiciary in collaboration with ILPD started the specialized short course program where currently 57 judges received this training.

In order to improve the quality of judgments, Judiciary will capitalize on upgrading the skills of the judicial staff by offering specialized training at a level of master's and diploma, exposure of judges to common law Judiciaries through exchange programs and continuing legal education. Thus, the following three outputs and activities will lead to the achievement of outcome 1.

1.4.2.1. Output 1.1: Specialized legal professional training at diploma level provided

This training aims at improving the knowhow skills of judges in art of judging. It will consist of developing and providing specialized and professional training programme at diploma level targeting judges of High Court, Commercial High Court, Commercial court and intermediate court who have not benefited from Master's programme. In total 120 judges will be trained in 8 specialized diplomas namely:

1. Practical aspects of contract and tort
2. International crimes and genocide ideology
3. Persons and family
4. Banking legal practice
5. Practical aspects of economic and financial crimes
6. Corporate law and insolvency
7. Criminal process and sentencing
8. Civil case management and judging

Activities to deliver the output are:

Activity 1: Develop Criminal process and sentencing diploma program:

To hire consultants to develop training programs

Activity 2: Provide training to 40 Judges on criminal process and sentencing diploma program

Activity 3: Develop civil case management and judging diploma programs:

To hire consultants to develop programs

Activity 4: Provide training to 40 Judges on civil case management and judging diploma programs

Activity 5: Upgrade the existing short courses programme of specialized courses and transform them into diploma programme for the six existing courses:

To hire consultants to develop program on civil case management and judging

To hire consultants to develop programs to upgrade the existing short courses

Activity 6: provide training to 40 Judges in six branches of law (Practical aspects of contract and tort, International crimes and Genocide ideology, Persons and family, Banking legal practice, Practical aspects of economic and financial crimes, Corporate law and insolvency)

1.4.2.3. Output 1.3: Continuing Legal Education for Judges is provided.

The purpose of continuing legal education is mainly to equip judges with skills to deal with:

- Challenges encountered or identified while processing cases: new aspects of newly enacted laws, aspects of criminal law)
- Emerging issues: human trafficking, money laundering, children rights, sexual violence).

These are trainings to be organized for a period not exceeding 5 days and will target judges at all levels of courts: Primary Courts, Intermediate Court, High Court, Commercial High Court, Commercial Court, Court of Appeal and Supreme Court for each court focusing on areas most needed.

Activities to deliver output:

Organize training on aspects of new laws as outlined below:

Activity 7: 3 days training on Law No 68/2018 of 30/08/2018 determining offences and penalties in general (new penal code) : Participants 294 Judges and 294 Registrars from all courts except Commercial Courts.

Activity 8: 2 days training on law No 30/2018 of 2/6/2018 determining the Jurisdiction of courts (participants 295 Judges and 295 Registrars of High Court, Intermediate Courts and Primary Courts, Commercial Courts and Commercial High Court)

Activity 9: 2 days training on law No 22/2018 of 29/4/2018 relating to the civil, commercial, labor and administrative procedure (participants 295 Judges and 295 Registrars of High Court, Intermediate Courts and Primary Courts, Commercial Courts and Commercial High Court)

Activity 10: 2 days training on law No 32/2016 of 28/08/2016 governing persons and family (Participants 274 Judges and 274 Registrars from all Courts except Commercial Courts, Court of Appeal and Supreme Court).

Activity 11: 3 days training on Upcoming criminal procedure law (Participants 294 Judges and 294 Registrars from all Courts except Commercial Courts))

Activity 12: Organize a 3 days training on emerging issues namely human trafficking, gender based and sexual violence, money laundering, children rights. The training will target:

- 6 Judges of Court of Appeal
- 12 Judges of High Court
- 36 Judges of Intermediate Courts

1.4.2.4 Output 1.4: Enhanced experience of judges and improved court management through exchange programs with other Judiciaries

This output intends to help Judges and court officials from Rwanda to share information with other Judiciaries about their court systems, legal issues, and the judicial role in rule of law and other practices applied to enhance the quality of judgment. It will provide an exposure of Judges to more experienced judges and more developed judicial systems.

The exchange programme will also help to learn more about principles and practices of the common law system related to:

- the practices of common law judicial system/ practice of use of precedence
- Art of judging in areas of genocide, GBV, Children, contract law, banking

In order to ensure that the knowledge gained from the tours is shared among judges, prior to any visit, Judiciary will prepare clear terms of reference on specific items to be learnt. At return, a report on skills gained will be prepared and submitted to the Chief Justice and a seminar will be organized to share with the remaining judges on lessons learnt.

The output indicator will be the number of exchange programme organized and the number of participants.

The activities to deliver this output will include:

Organize 3 study tours for judges and registrars in African (Kenya) and western (Netherlands and Canada) countries. Each tour will be for 2 weeks in western countries and 1 week for African countries.

Activity 13: Organize a study tours in the **Kingdom of Netherlands**: 3 Judges and 1 Registrar from High Court Chamber for International Crimes, 3 Judges and 1 Registrar from Court of Appeal, 1 Inspector from Supreme Court

Activity 14: Organize a study tours in **Kenya**: 6 Judges, 6 Registrars from Intermediate Courts (1 from each court) and 1 Inspector.

Activity 15: Organize a study tours in **Canada**: 1 Judge from Supreme Court, 2 Judges from Court of Appeal, 3 Judges from High Court and 1 Inspector.

1.4.3. Outcome 2: Case backlog reduced

Currently, the case backlog represents 25% of all pending cases by end of June 2018. The target is to achieve the rate of 10% by end of 2024.

In order to support judges to prepare their cases, the Project will provide legal researchers and legal advisors to conduct legal research in various areas of law. They will collect legal documents such as laws, books and precedents related to a legal issue identified in cases; analyze them before they are reviewed by judges. The time a judge takes to analyze one case will be reduced as a result of the research done by researchers and advisors, hence increasing the number of cases judged. Specifically, they will intervene in the following areas:

1. Conducting legal research to collect information on legal issues
2. Drafting legal opinion
3. Drafting bench memos to be used by judges in answering the exceptions/ arguments put forward by litigants

This helps not only to speed up the case processing but also improves the quality of judgment since decisions will be based on fully researched information.

1.4.3.1. Output 2.1: Technical assistance in legal research provided.

The contribution of legal research will be to spare the time of judges during the search of legal documentation that will aid in finding a solution to a legal problem during case processing.

Activities to deliver the output:

Activity 16: Hire local legal researchers

- Supreme Court : 2

1.4.3.2. Output 2.2: Improved transparency during court proceedings through the use of court technologies

Transparency in court proceedings increases the quality of judgments and the confidence of citizens in court decisions and enhances the access to justice, as well as supports the knowledge development.

The outcome will be Transparency in court proceedings improved; the output will be the number of cases of which the proceedings are publicly available.

Currently, the Judiciary use technology to manage all processes of cases in courts. The future of the management of Rwanda Judiciary courts activities will be based on the use of technologies. This implies proceedings will also be more transparent if they can be followed by court users and the general public electronically.

In the efforts to fight against corruption and bad practices in courts, Judiciary in collaboration with Transparency International has developed the online system, used by litigants.

The system was initially thought by transparency as a simple system that would allow litigants to file their complaints on corruption into the court inspection which would then process the documents manually and post the conclusion in the system for the litigant to see without any work flows.

It later evolved into a more complex system that would allow litigants to file complaints on corruption and procedure malpractice to inspection who would be able to assign the task to inspection members and such flow is tracked until the document closure. Also, it was expanded to track not only documents submitted by citizens, but also documents submitted by the Bar Association, Prosecution, Correctional services and their heads to track such issues submitted by their staff.

Most importantly, it was evolved to handle requests for special review into all higher courts as defined in the new procedure laws and to be used by both court president and chief registrar. This carries logic, workflows and need for upload of case documents. It also involves the office of ombudsman for litigant to appeal decision to reject their special review cases.

However, although the functionalities were improved and changed and system was being made heavier, there was no upgrade to its underlying technologies and code to better handle increased load in terms of functionality, usability and document files.

It is in this regard that we desire an upgrade to the systems underlying technology such as the data and database structures, code, improved ability to handle upload of big and many documents, purchase needed licenses etc to make the system sustainable.

This system needs to be upgraded to fit for current needs of user and provide training to end users.

The activity to deliver this output will consist of as:

Activity 19: Upgrade 10 2 g System to allow litigants and citizen to file their complaints in Inspection of courts, denounce suspects of corruption practices.

Activity 20: Acquire 2 Digital courts recording for Court of Appeal

Activity 21: Organize training end users (Court staff and citizens) on the use of 10 2 g

system: 3 days training for public users (cyber cafes, facilitators and any other interested citizens) at each TGI around 25 people ie 300 trainees. Whereas for court staff, it would be 3 day training for court presidents and chief registrars (126).

Activity 22: Pay hosting fees of 10 2 g System

Activity 23: Acquire 5 smart screens: 3 in Supreme Court, 2 for Court of Appeal.

Activity 24: Acquire 290 laptops for 145 Judges and 145 Registrars of Primary Courts. The staff in Primary Courts uses old versions of desktop computers for last 10 years. In addition to this, in reform of June 2018, new 25 judges and 25 registrars were recruited in Primary Courts in efforts to reduce case backlog. All of them need new laptop computers capable to use Integrated Case Management System (IECMS) during judgment preparation, court hearing and research.

Activity 25: Acquire 38 projectors and 38 projection screens for Intermediate Courts, High Court and its 5 Chambers and Court of Appeal.

1.4.4. Outcome 3: Adequate and easily accessible Legal information produced and published.

Legal information is a tool which assists judgments in analysis of legal matters and determination of court decisions. It helps to improve the quality of judgments and speeding up case processing especially by referring to previous cases decided by courts

The Judiciary will improve the accessibility to legal information, mainly law libraries both electronic and physical and electronic, production and publication of law reports.

Specifically the law reports will improve the accessibility and adequacy of legal information by:

1. Harmonization of similar cases rendered by different courts of Rwanda
2. Reduction of cases in courts based on the facts that citizens will have access on rendered cases which can results in providing solution on their issues without attending the courts.
3. Advocates will improve they pleadings though the accessibility to precedent and help to speed up cases proceedings.
4. Law reports translated in English facilitates foreigners to easily access Rwandan Case laws to facilitate the knowledge sharing with other EAC judiciaries and other foreigners interested in Rwanda Judiciary performance such as investors.

1.4.4.1 Output 3.1 Technical Assistance in law reporting and small claim procedure provided

Law reports will equip judges and prosecutors and other legal practitioners with information on leading cases decided by higher courts.

The law reporting unit was established in 2015 under the Capacity Building project. At the end of this project, Judiciary recruited 3 permanent Law reporters.

Currently they produce few law reports that do not cover all the different branches of law making their usefulness difficult. The target of Judiciary is produce law reports for each of the following 6 branches of law:

1. Commercial law
2. Criminal law
3. Administrative law
4. Labor law

5. Family law

6. Financial law

Key activities to avail legal information will be:

Activity 26: Hire 4 Law Reporters

Activity 27: Produce, print and publish law reports (4 volume per year), 150 copies for each volume that is 600 copies each year.

Activity 28: Publish law reports electronically for easy sharing among judges and other legal practitioners locally and worldwide as well as archive them electronically.

Hire a consultant to develop small Claim Procedure bench book

Activity 29: Elaborate and produce a bench book on Small Claims Procedure : hire a consultant to develop small claim Procedure bench book

Activity 30: Print and publish 123 (3 for each of 41 Primary Courts) bench book on Small Claims Procedure.

1.4.4.2. Output 3.2. The latest law books acquired and accessibility to online law libraries provided.

In order to help judges to access to useful legal information, Judiciary will acquire latest law books to equip its central library and court libraries and provide access to online law libraries to judges.

The activities to deliver this output:

Activity 31: Acquire 750 latest law books in the following branches of law

2. Criminal law

3. Administrative law

4. Labor law

5. Family law

6. Financial law

Activity 32: Subscribe to two online law libraries for three years at 10 2 g and 10 2 g

1.5. PROJECT IMPLEMENTATION ORGANIZATION

This project will be implemented by the Single Project Implementation Unit which will be based in the Judiciary of Rwanda for a period of **three (3) years**. A Steering Committee will be established to closely monitor the project implementation; it will comprise of Secretary General of Judiciary, Secretary General of Prosecution Authority, Inspector General of Judiciary, Representative of Court of Appeal, Representative of ILPD and Single Project Implementation Unit coordinator and a representative of Ministry of Finance and Ministry of Justice, representative of civil society represented by Bar Association; it will be chaired by the Secretary General of the Judiciary of Rwanda. The Steering Committee will meet every semester to monitor Project execution as well as provide leadership and risk management input to the Project team. The JRC Steering Committee will produce and provide regular narrative and financial progress reports to donor.

An already operational Special Projects Management Unit (SPIU) which manages other projects in the Judiciary and NPPA will allocate a dedicated Project manager to this project and has other necessary project staff including a Procurement Specialist, IT officer/ Projects Accountant and Projects Secretary, Quality assurance support and technical advisory services for project execution.

Organization of training:

There will be collaboration with ILPD during development of training programmes for diploma and short courses and deliver them to trainees and a mandated institution in legal training. The project will provide for trainers and ILPD will provide facilities.

Judiciary Experience in integrating gender

Judiciary has experience in integrating gender in its project and it will be considered in the current project in the following areas:

- 1. In delivery of justice:** women and other vulnerable groups are the group of population most impacted when the judgments do not meet the expected quality. This can be classified in GBV related cases, Family and minors cases, land and property litigations. This project will enhance the skills of judges and improve the quality of judgment, benefiting both men and women who have cases in the court.
- 2. The interventions identified** in this project will cover both men and women. The women in Judiciary represent 50% of judges and registrars. Training them will enhance their contribution to the quality of judgment.

Milestones / Disbursement / Procedures / Reporting

The disbursements would be made against predefined milestones on yearly basis. The SPIU would have to provide supporting documentation as confirmation for disbursements. The project would use Rwanda Public Procurement Authority (RPPA) procurement guidelines for all goods and services under the project.

A special Bank account through which all project funds would be channeled will be opened in the

Contextual risks

Rwanda has for the second year running ranked third least corrupt country in Africa, according to the latest Corruption Perception Index, 2017, released by Transparency International. Globally, Rwanda ranked 48th least corrupt nation among 180 countries assessed, improving two places from 2016. Project risk analysis of this project is to increase the probabilities and impact of opportunities and to decrease the probability and impact of threats. We are committed to address prospective risks of this project proactively throughout project cycle.

Organizational risk

- 1. Continuity:** Judiciary is one of three arms of Government of Rwanda. There is no risk related to its continuity. With regard to continuity of project activities, the intent of the project is to increase the capacities of judges. The capacity acquired will need to be applied in work. Judiciary is among the institution with low turnover rate in the Country and it is expected that Judiciary will benefit the skills acquired for a sufficient time.
- 2. Expertise and independent status:** Judiciary has expertise in Project management. Over past 17 years, it has worked with the Kingdom of Netherlands, European Union, UNDP, Canadian Cooperation, Investment Climate for Africa and World Bank Projects. It has control systems in place and working properly. It is received unqualified audit opinions from Auditor General and independent auditors of different projects.
- 3. Communication related to fraud and unacceptable behavior:** high standard ethical behavior is required for all Judiciary staff. The management organizes an annual anti-corruption week, and a clear message is communicated to employee on stance of Judiciary with regard to fraud and unacceptable behavior. The policy is zero corruption in courts staff. Due to corruption and other unacceptable behavior, since 2004, up to 2017/2018, 41 judges and registrars were dismissed, 46 were punished with other disciplinary sanctions. According to Citizen Report Card, 2017 published by Rwanda Governance Board, 3.9% of said that they faced corruption practices in courts, while, 4.67% faced the experienced bribe related practices in courts according to Rwanda Bribery index, 2017 published by Transparency International Rwanda.

With regard to procurement, the breach of procurement law is a criminal act and is punished by Rwanda Criminal law. The procurement law contains the ethical principles. All persons involved in procurement process have to abide with these principles failure to which they are punished.

Sustainability of project and results

This project is a consolidation of what Judiciary has already achieved, mainly by strengthening in-house capacities of Judges. The training will start focus on Judges who will train other in subsequent years. Since the Government of Rwanda has training facilities in ILPD school, once there is skilled people in Judiciary under existing arrangements in Justice sector, there is no doubt that the results will be the milestone over which Judiciary will be able to sustain and make them more fruitful at the end of the Project.

At the end of the project, it is expected that the achievement gained will help Judiciary to control the level of case backlog toward to target of 10% by end 2024. The synergy of efforts gained from this project outcome together with measures taken by Judiciary such as the court restructuring resulted in creation of Court of Appeal to ease the load of cases in Supreme Court and increase the number of judges and registrars in Primary courts is leverage for case backlog projected downward trend.

With regard to additional staff recruited under the project, their contribution will be to support the efforts of permanent staff during project lifetime. As the most of current challenges including case backlog are expected to decrease over the project lifetime, at the end of the project, the permanent staff will be able to manage the remaining workload. Where the workload requires keeping the project staff in position at the end of the project, the Government of Rwanda will include the staff in Judiciary structure and cater for cost involved.

The technology and equipment acquired will be maintained from Judiciary recurrent/ operational budget.

Own contribution

Judiciary will avail the judges and registrars to be trained, the transportation of trainees to the area of training. In collaboration with ILPD training rooms will be provide. Some training facilities such as trainee computers where needed etc. Judiciary will also provide offices and equipment for staff working in project management.

Monitoring and Evaluation

Reports and audit

Reporting will be done semi-annually for the first year and annual report during the subsequent years to the Donor and every year there will be an external audit.

Evaluation of knowledge and skills:

The impact will be evaluated over long term period using the overall indicators used to measure the quality of judgments.

- The Immediate results will be assessed using the criteria already in use in ILPD.
- For diploma programme, the teaching method is module based and at completion of each module, there is a test.
- For continuous legal education (short courses), also ILPD applies the pre and post training test to measure the change resulting from the training.

II. NATIONAL PUBLIC PROSECUTION AUTHORITY

2.1. GFTU CONCEPT NOTE PERTAINING TO FURTHER DUTCH FUNDING (YEAR 2019-2021)

2.1.1. Introduction: The Creation of the Genocide Fugitive Tracking Unit (GFTU)

Founded on 14 November 2007, the GFTU has been at the forefront of Rwanda's efforts to:

- identify the whereabouts of genocide suspects who have settled abroad;
- investigate allegations against them;
- cooperate with national prosecution services and international justice bodies to bring them to justice in their host countries' jurisdictions or
- Alternatively facilitate their extradition to Rwanda for their trial.

2.1.2. GFTU achievements in general

Since its inception in 2007, the GFTU, through its investigations, managed to send 762 Indictments and Arrest Warrants, which have been issued in 33 countries in Africa, Europe, North America and Australia.

Out of those issued indictments and warrants, 22 genocide suspects have been tried in host countries such as the Netherlands, Belgium, Switzerland, Canada, Norway, Sweden, Germany, Finland and France.

Pursuant to Extradition requirements as stated under Article 7 of the Convention on the Prevention and Punishment of the Crime of Genocide Adopted by Resolution 260 (III) A of the United Nations General Assembly on 9 December 1948, Nineteen (19) fugitives were either extradited by States or referred to Rwanda by the former ICTR based on Rule 11 Bis of the ICTR Statute, relating to referral of cases to National Jurisdictions.

These nineteen (19) persons came from United States of America (USA), Canada, Netherlands, Norway, Denmark, Germany, Uganda and referrals from the ICTR. The above nineteen (19) persons, have either been tried by classical courts after the review of decisions rendered by Gacaca; or are on trial or have completed trial proceedings before the International Crimes Chamber (HCICC) of the High Court.

2.1.3. GFTU achievements with the previous Dutch funding

The Netherlands 5 year (2012-2017) funding Project of GFTU activities through the Judiciary, was paramount to the success of GFTU mandate in investigation and tracking 1092 case files of genocide fugitives living abroad. With the previous Dutch Funding, GFTU managed to record the following achievements:

- ❖ Investigators completed 794 out of 1092 case files, and also finalized the investigation of 395 cases files of fugitives co-perpetrators deriving from investigations they conducted in Muhamga, Rubavu, Karongi, Ngororero, Rutsiro, Huye, Gisagara, Nyamagabe, Rusizi, Ngoma, Kayonza, Rwamagana, Bugesera, Gatsibo, and Nyagatare Districts.
- ❖ From those investigations about 762 indictments were issued. From above investigations and upon case file examination, 13 cases were closed and charges dropped against Fugitives living in Belgium, Cameroon, USA and Norway.
- ❖ Rogatory Commissions teams from The Netherlands, France, Norway, Germany, Sweden, Denmark, Belgium, Canada and USA came for further investigations on the indictments that had been served through the work of the GFTU. From those initiatives, 10 fugitives were brought back to Rwanda for trial, whereas 7 cases were prosecuted in host jurisdictions.

- ❖ Regarding 71,658 Gacaca cases handed over to GFTU as a result of the closure in 2012 of Gacaca Service, 300 case files were investigated and indictments issued, while 87 files were found not to be fugitives' cases across the borders as those people were in Rwanda, having either completed serving their sentences, or still serving sentences while others at liberty. The outcome of these investigated cases of persons found in Rwanda were communicated and sent to relevant prosecution offices across the country, for handling them. Consequently, the GFTU has handled 387 cases out of 71,658 cases inherited from Gacaca Service. This means that the remaining workload amounts to 71,271 cases.

2.1.4. Challenges

Upon completion of the previous Dutch Project, the GFTU faced challenges which have impaired on the continuity of its activities. There are as follows:

- Sustainability issue at the end of the previous Dutch Funding, investigators stopped going to the field during two months while other alternatives were explored as to cover the shortage of funding due to the non-continuation of the Dutch Project;
- Follow-up on actions taken by States in which indictments, international arrest warrants and extradition requests have been sent in order of securing a feedback;
- Lack of Translation facilities to avail indictments, international arrest warrants and extradition requests to be sent in country for which German, Portuguese and Spanish are the working languages. In the event a Translator is hired by the Dutch Project, he shall be overloaded if handling alone the translation in English of all needed documents to be sent abroad and in addition; those to be sent to various Embassies before they are being translated in German, Portuguese and/or Spanish;
- Capacity building for Prosecutors and Investigators
- Retention of investigators who have been already trained;
- Big number of issued indictments, in comparison with cases which were tried abroad and those which were extradited to Rwanda;
- Change of suspects' identities causing difficulties to track them

The GFTU shall, with the additional Dutch Project, address challenges it faced during the previous Project; in tackling the issue of shortage of funds which are needed for pursuing investigations, tracking and issuance of qualitative Indictments; as well as in closely following-up case files sent abroad.

Also, the impediment of availing documents in German, Portuguese and Spanish shall be addressed by firstly translating needed documents in English and afterwards relying upon Rwandan Embassies in countries requesting documents in German, Portuguese and Spanish; to assist in providing translation in those languages.

The capacity building of Prosecutors and Investigators shall be addressed with the additional Dutch Funding Project. Moreover, the retention of trained investigators shall be dealt at the decision making level, to ensure that the GFTU does not be hampered by the redeployment elsewhere of trained Investigators

2.1.5. GFTU's on going work

Both the ICTR and National Jurisdiction for Gacaca Services have completed their mandate with a remaining work to be accomplished and falling partly under the jurisdiction of the NPPA's Genocide Fugitive Tracking Unit (GFTU). Although the International Residual Mechanism for Criminal Tribunals

("Mechanism") has taken over tasks left by the ICTR, the GFTU still works in collaboration with the Mechanism to investigate and track the Eight (8) fugitives who are still at large

Upon the completion of its work on 18 June 2012, the National Jurisdiction for Gacaca Services transferred to the GFTU a list of 71,658 genocide fugitives convicted *in absentia*, whose whereabouts are unknown adding to 1189 files which the GFTU was working on. Building on workload inherited from the National Jurisdiction for Gacaca Services, the GFTU plans to reinforce its capacity to enable it bring to justice large numbers of Rwandan genocide suspects who are still enjoying impunity in foreign countries.

2.1.6. Remaining work to be done in ten years' period

Follow-up on cases/indictments sent to various countries. In the 2012-2017 Dutch Project, no follow-up on actions taken by countries in which indictments, international arrest warrants and extradition requests were sent. With the new Dutch Funding, a follow-up of cases shall be made in continents of Africa, Europe and America. In Africa, follow-up missions shall be conducted in countries which have already signed an Extradition Treaty with Rwanda, specifically Uganda, Kenya, Zambia and Malawi. In Europe, France and Belgium will be visited and in America, follow-up missions will be effected in the United States. Those countries in Europe and America have been chosen due to their willingness of actively working on requests sent by Rwanda.

As shown in the previous sections, the GFTU has accomplished commendable achievements with the previous Dutch Funding. Nonetheless, there is a remaining workload inherited mainly from the National Jurisdiction for Gacaca Services and this requires the availability of financial and human resources to enable perform the remaining work which is anticipated to be completed in ten years period as follows:

In addition to significant responsibilities inherited from the National Jurisdiction for Gacaca Services, the GFTU has dealt with 1189 active files which are almost completed with both the GoR funding and previous Dutch Funding. As indicated earlier, with the New Dutch Funding, the GFTU shall embark on investigating some of 71,271 cases tried by Gacaca *in absentia*, for the 10 years period ahead. There are also Five (5) fugitives still at large, which the ICTR before its closure in 2012, transferred to Rwanda.

Concerning the 71,358 files inherited from the National Jurisdiction for Gacaca Services, thorough tracking and investigation need to be conducted in order to determine the current status and possible whereabouts of those tried *in absentia* who are still wanted persons. Besides the work being done with the additional Dutch Funding as indicated in the next paragraph, the NPPA shall work in conjunction with other stakeholders such as (i) the Ministry of Justice at policy level; (ii) the Ministry of Local Government to identify and cross-check from the village level up to the district level across the country, particulars of persons tried *in absentia*, in order to accurately determine those who are in the country and those who had gone abroad; (iii) the CNLG to provide information pertaining to judgments and specific courts which rendered verdicts of persons tried *in absentia*; (iv) the Rwanda National Police to give support for the identification of persons tried *in absentia* and (v) the Rwanda Investigation Bureau for providing more investigators assigned to work on those cases. The whole exercise shall enable to trim the large number of 71,271 files and enable the GFTU mainly focus on cases of persons tried *in absentia* who are abroad.

As a starting point, the GFTU has already tasked its investigators to work on those cases of persons that the National Jurisdiction for Gacaca Services sentenced *in absentia*. In doing so, when on weekly field missions to conduct their planned investigative work, investigators are also assigned each twenty (20) files concerning those that the National Jurisdiction for Gacaca Services sentenced *in absentia*; in order of gathering any information concerning their whereabouts. The following step will be to investigate

cases of persons found to have fled Rwanda and when need be, to issue an indictment, international arrest warrant and extradition request. It is worth to note that the above approach had already enabled the GFTU to send 300 indictments in various countries hosting fugitives and work on 87 cases of persons found in Rwanda, which cases were communicated and sent to relevant prosecution offices across the country, having jurisdiction to handle them.

Therefore, the GFTU is seeking further financial support from The Kingdom of the Netherlands in order to sustain its capacity in investigations and in compiling case files as well as issuing indictments, International arrest warrants and where appropriate, extradition requests.

2.1.7. Information relating to how GFTU work with RIB Investigators

It was through the Cabinet Resolution of 14 November 2007, that GFTU was created and the Resolution in paragraph 7 (b) instructed the Inspector General of Police to assign investigators to the GFTU to work with the newly formed Unit. Investigators were working with the former Criminal Investigation Department (CID) which has now become the Rwanda Investigation Bureau ("RIB").

The Government of Rwanda established RIB through a Cabinet Resolution of 10 August 2016. The latter is fully operational Pursuant to Law N° 12/2017 of 07/04/2017 which establishes its activities. RIB assumed services of CID and it has, *inter alia*, a duty to facilitate the GFTU work, by providing investigators tasked to conduct investigations. Currently, the GFTU has 5 investigators and in a near future, additional 4 investigators will join the team to be 9 investigators working within the GFTU.

2.2. NEED FOR FURTHER FUNDING OF GFTU ACTIVITIES

The GFTU still needs to benefit from the Dutch Funding regarding core support and project support (for project support see the logframe):

- ✓ For core support, the Dutch further funding will enable:
 - ❖ Hiring services of 4 Drivers, 3 Data Entry Clerks, 1 Senior Legal Advisor, and 1 Translator;
 - ❖ Providing support for field investigation activities (Mission fees and fuel for four vehicles);
 - ❖ Providing Insurance policy coverage and maintenance of 4 vehicles;
 - ❖ Providing Communication for investigators and the GFTU Head;
- ✓ For project support, the Dutch further funding will enable:
 - ❖ To organize training and refresher training for Investigators
 - ❖ To conduct two follow up visits per year to 6 countries in total, namely Kenya, Zambia, Uganda, Malawi, one to Belgium & France and USA
 - ❖ To write 10 statements per year and disseminate them via Rwandan embassies to local authorities in host countries
 - ❖ To organize a training and a refresher training for prosecutors
 - ❖ To secure a complete application for a NUFFIC scholarship for Prosecutors to pursue a 12 month Master's Degree
 - ❖ To organize training from ILPD on amended and new relevant laws for Prosecutors
 - ❖ To Organize study tours in The Netherlands for Prosecutors to sharpen their skills

To be more specific, for project support, in modern world, the specialization and training of prosecutors in the field of work is key to success. When combined, the GFTU and the International Crimes Unit ("ICU") have 14 Prosecutors. On one hand, the GFTU carries the conduct of investigations of genocide fugitives' cases. On the other hand, the ICU after being created as a result of extraditions from States and referral cases from the ICTR performs day-to-day tasks of prosecuting extradited and/or transferred cases. Out of the 14 Prosecutors working within the GFTU and the ICU, only one of them has a Masters in International Criminal Law.

In order of enhancing skills to qualitatively draft indictments and extradition requests, as well as improve their written and oral advocacy for effective pleadings before the specialized Chamber (of the High Court) which handles international crimes; the GFTU and ICU Prosecutors need specialization in International Criminal Law, specifically in areas of Relevant Principles of International Criminal Law, Substantive Crimes (Genocide, Crimes against Humanity and War Crime). Short Courses on Modes of Responsibility, Pleading Techniques a Prosecution Perspective, Circumstances Excluding Responsibility, International Criminal Procedure, with a comparative analysis with Rwandan Criminal Procedure, Review of the Transfer Law and its application, Fundamental Procedural Rights in International Criminal Law: Rights of the accused, Examination-In-Chief and Cross-Examination, Witness' protection and vulnerable witnesses, Legal research, written and oral advocacy.

Those programs can be provided by attending trainings in Rwanda and Masters Programs in The Netherlands, France and/or any other country where Prosecutors will be able to secure registrations for Masters Programs.

With the promulgation of newly enacted laws, the GFTU and ICU Prosecutors need also training on New Laws to have a better understanding of them, such the 30 August 2018 Law Determining Offences and Penalties in General, the Law on the Crime of Genocide Ideology and Related Crimes of 22 August 2018 and the Law on Criminal Procedure which will soon be promulgated. Those trainings can be provided by the Institute for Legal Practice and Development, which can also initiate training for trainers identified within the NPPA who would master techniques of training their colleagues on any new law to be enacted in the future. It appears that the Prosecution's mandate is different from the Judiciary one; which justifies that the training for Prosecutors on amended laws need to be tailored to the investigation and prosecution of cases in light of new laws.

As far as study tours are concerned, Prosecutors will travel to The Netherlands to exchange with their peers of international courts (such as the International Criminal Court) in order of sharpening their skills.

Training of GFTU Investigators

There are needs to train investigators in investigation procedures, focusing on modern techniques for investigation, the collecting and processing of evidence from statements, crime scenes data, seized documents, intercepts, imagery and open sources and witness' protection.

The Institute for International Criminal Investigations ("IICI") in The Hague is one of different Institutions which can provide needed training for Investigators working within the GFTU who also need to acquire a deeper understanding of how investigations of International Crimes are conducted from those of ordinary crimes because the latter do not have the same complexities as International Crimes. Notwithstanding the fact that investigators from RIB have knowledge of investigating crimes, however, they still need to be acquainted with specificities of investigating international crimes which fall under the Mandate of the GFTU tasked to handle cases involving Genocide, Crimes against Humanity and War Crimes. In addition, even though Investigators face some challenges while gathering evidence of international crimes due to the fact that many years have elapsed, concepts of gathering evidence remain the same for national and international courts in all times and any challenge caused by the elapse of time is dealt on a case by case basis (For example, conducting exhumations when there

is a necessity of verifying identities of victims, corroboration of various testimonies for attesting the occurrence of crimes, etc.).

Sustainability

As shown in sections related to investigations of cases inherited from Gacaca, at the end of the three years' Project; investigations of those cases will have been done to a large extent and remaining cases will then be dealt with the support of the regular budget.

Also, investigators and prosecutors will have benefited from the capacity building programs during the three years' project, which will provide qualitative investigations, tracking, issuance of Indictments and prosecution cases.

Finally, during the three years' project, mechanisms for following-up case files sent abroad will have been efficiently established, as to ensure the continuation of the said activity, after the three years' project, in a successful manner, with the support of the regular budget.

2.3. CONCLUSION

The second phase of the Dutch Project shall contribute to improve the quality of investigations, the drafting of indictments and the conduct of prosecutions before courts; with strong cases and thus; ensuring the fight against impunity.

II. ACTIVITY APPRAISAL

2.1 Contribution made by the activity to BZ policy objectives (policy relevance)

2.1.1 Description policy relevance

The Netherlands has a longstanding relationship with the Justice sector in Rwanda and the Judiciary in particular. During the genocide, the Judiciary of Rwanda as well as other organs of State lost human resources, infrastructure and materials. From 1998, Rwanda initiated the process of reconstruction and reform of State organs and public institutions. The Judiciary was part of this process. The first reform of the Judiciary was funded by the Kingdom of the Netherlands. It proposed a new structure of courts in Rwanda. Laws were revised to accommodate the new structure. This reform was integrated in the 2003 Constitution that was revised in 2015.

To support this reform in the Judiciary, the first project called "Projet d'Appui aux Cours et Tribunaux, PACT1" financed by the Kingdom of Netherlands, helped the Judiciary to have adequate infrastructure and 4 new court buildings. The support received through PACT 1 also funded the continuous training of new judges and registrars to make them conversant with new laws. It further provided basic court equipment and IT infrastructure. All higher courts were equipped with computers and printers while lower courts (Tribunaux de District et Ville) received one computer and one printer for each court. This project supported the elaboration of the first Judiciary Strategic Plan 2005-2007 and provided the transport equipment (13 vehicles) for all new High Court Chambers, Inspectorate of Courts and Intermediate courts.

At the completion of PACT 1, the Judiciary had to tackle the remaining challenges mainly related to IT infrastructure, access to justice and administration of justice and strengthening independence of the Judiciary. To address these challenges, the Kingdom of the Netherlands provided an additional support which resulted in PACT 2 "Support project to the Rule of Law" that started in 2007 and ended in 2011. In 2012 new challenges emerged notably the trial of genocide cases transferred to Rwanda by ICTR and foreign countries.

In order to handle these challenges, a third Project called "Capacity Building of Judiciary and Prosecution for Extradited Suspects of the Genocide" funded by the Kingdom of the Netherlands was initiated and aimed at strengthening national capacities of the Rwandan judiciary and prosecution to deal with the trials of extradited suspects of the genocide in a manner that fully complies with all international and UN standards for fair trial.

In 2018 the decision was made to phase out bilateral development cooperation in Rwanda. This meant that any new project would be also the last. Where the previous project still had a strong infrastructural component, the current project will focus more strongly on building capacity and improving quality and consolidating what has been achieved in the past three projects as planned in the MACS. As the Netherlands transitions out of development cooperation in Rwanda, ensuring continuation of past results is important, especially regarding the relations with government institutions. Results so far are expected to be sustainable, as Dutch interventions have for the most part been embedded in Rwandan institutions.

Sustainability

This project is a consolidation of what Judiciary has already achieved, mainly by strengthening in-house capacities of judges. The training will focus on judges who will train other in subsequent years. At the end of the project, it is expected that the achievement gained will help the Judiciary to control the level of case backlog toward to target of 10% by the end of 2024. The synergy of efforts gained from this project outcome together with measures taken by Judiciary such as the court restructuring resulted in creation of Court of Appeal to ease the load of cases in Supreme Court and increase the number of judges and registrars in Primary courts is leverage for case backlog projected downward trend.

With regard to additional staff recruited under the project, their contribution will be to support the efforts of permanent staff during project lifetime. As the most of current challenges including case backlog are expected to decrease over the project lifetime, at the end of the project, the permanent staff will be able to manage the remaining workload. Where the workload requires keeping the project staff in position at the end of the project, the Government of Rwanda will include the staff in Judiciary structure and cater for cost involved. The technology and equipment acquired will be maintained from Judiciary recurrent/operational budget.

2.4 Cooperation, harmonisation and added value

In addition, **10.2 a** will support the Judiciary to:

- train IECMS users, for which the judges can use the laptops which are provided in this project.
- Support the implementation of a court performance management module, which will complement the visibility of the qualitative improvement of individual judges.
- Implement a Law reporting module in IECMS which will be linked to the law reports and precedence system, which is favourable for this project as many new law reports are expected to be produced.
- Provide specialized training in economic and financial crimes and cybercrimes, which is different than the training that we are providing.

2.5 Channel and aid modality (including alignment)

As the Judiciary is part of the government, the most logical option is to work with the government if you want to improve the work of the Judiciary. Instead of providing budget support as we used to do until 2018, this project support allows us to better target the problems we wish to address as well as better monitor the use of funds and achieved results.

The Judiciary will avail the judges and registrars to be trained and the transportation of trainees to the area of training. In collaboration with ILPD training rooms will be provided. Some training facilities such as trainee computers where needed will be provided. The Judiciary will also provide offices and equipment for staff working in project management.




