Subject: Request for extension of project closure date

The Supreme Court received assistance from the Royal Kingdom of the Netherlands through the Netherlands Embassy in Kigali to support *Capacity Building of the Judiciary and Prosecution for* extradited suspects of Genocide, Phase II, N^o 4000002774 Programme;

This programme is designed to improve quality of judgments expressed in terms of its predictability and consistency. The quality of judgment is measured by the rate at which cases are overturned at appeal level and the citizens' confidence in decisions of courts' timely judgment, transparency of court proceedings as well as fairness of court decisions.

The Arrangement of this programme was signed on 18th June 2019 and was expected to be implemented from 1st June 2019, project activities completed by 30th June 2022 and finalize with reporting by 1st October 2022.

Reference is made to the approved project annual report of July 2019- June 2020, on p 41 and July 2020-June 2021 on p 49, in which the Judiciary proposed an extension of the project to allow implementation of the delayed activities, production and submission of Project final report, final audit and Project closure accounts without additional budget.

Reference is also made to the meeting held in the Supreme Court on 23rd November 2021 between the delegation of the Netherlands Embassy in Rwanda, the Judiciary and the National Public Prosecution Authority in which the current project activities were discussed, different challenges encountered and solutions proposed.

Premised on this background, the Supreme Court is requesting for an extension of the project duration due to the following raisons;

a) Delays on budget accessibility:

From **31**st **August 2019** when the project received the first instalment from the donor, the Judiciary was only allowed to access funds to cover salaries for the two-project staff that were in place then. All the other activities were required to start after the budget revision in **January 2020**.

b) Delay in the recruitment of the required staff:

This activity delayed due to Covid-19, the recruitment process of the Project staff and the Judiciary experts had to be conducted following the recommendations/guidelines issued by both the Ministry of Public Service and Labour and the Ministry of Health. In the bid to comply with measures put in place to curb the spread of Covid-19, all planned recruitments were put to halt/delayed.

Reference is further made to the various cabinet resolutions taken by the Government from 14th March 2020 up today for fighting against the spread of Covid-19 pandemic; public health safety measures including working from home were strictly enforced, physical meetings were discontinued, movements at certain times were restricted/controlled hence delaying the implementation of a number of project activities. Delayed project activities referred to are in the attached appendices.

c) Delayed accreditation of Specialized legal professional programs

The High Education Council (HEC) has so far accredited three legal professional programmes at diploma level out of eight planned programmes.

Your Excellence, based on all the highlighted above, the Judiciary is requesting for a no cost extension of one year and three months that will commence from 1st October 2022 to 31st December 2023 to be able to accomplish all milestones of this project.

It is expected that during this extension, the project will complete all remaining activities detailed in **the attached annex** by 30 September 2023 and then carry out the final audit, prepare and submit the final project report as well as closure of accounts and handover by **31**st **December 2023**.

CONCEPT NOTE ON BUDGET REALLOCATION OF THE CURRENT

PROJECT FUNDED BY THE NETHERLANDS

A. BACKGROUND

- The Government of the Netherlands has provided assistance to the National Public Prosecution Authority (NPPA), to support the Genocide Fugitives Tracking Unit/International Crimes Department (GFTU/ICD) in, *inter alia*, its investigation of genocide fugitives still at large, through the funding of two projects, with the first phase from 2012 to 2017, and the ongoing phase that started in 2019.
- 2. In the course of the current Project execution, crucial needs have arisen, such case backlogs constrained more by the limited number of staff to deal with the increasing number of cases thus necessitating a reallocation of budget lines, to cater for those needs as they are not funded in the Project.

B. PURPOSE

- 3. The purpose of this Concept Note is to request a reallocation of budget line, to fund the hiring of prosecutors at the Primary Court level, as there are not funded in the current Project execution.
- 4. The needed reallocation shall transfer funds from the already approved budget lines into the new budget line, dedicated for the hiring of prosecutors at the Primary Court level.

C. SCOPE

- 5. The requested budget reallocation shall cover the payment of:
- <u>Hiring</u> of contractual Prosecutors at the Primary Court level: NPPA is planning to hire contractual prosecutors at the primary court level to avoid case backlog that might rise due to the current trend of crime nationwide. In addition to that, cases being reported to NPPA are on the high increase compared to the previous years. Here is a quick example whereby NPPA Annual Report of 2020-2021 shows 67,512 cases received, compared to 43,226 in 2017-2018 thus necessitates the increase in number of personnel working on those cases to avoid backlog in the future but also allow our staff to be able to attend other capacity building workshops and trainings funded by Dutch project.

D. REALLOCATION AMOUNT FOR BUDGET LINES

- 1. The budget reallocation shall be equivalent to the following:
 - Amount of 5.1.2a Rwf for hiring prosecutors at the Primary Court level which shall deducted from the balance of the budget trainings.
 - This amount shall cater for payment of 9 contractual prosecutors who are each paid a gross salary of 5.1.2a frw per month.
 - The contractual staff will be hired for a period of 20 months (11 months for 2022 starting contract execution on 1st February 2022 and 9 months for 2023).

E. EXPECTED OUTCOME

- 6. The budget lines' reallocation shall enable the provision of:
 - Clearance of case backlog.
 - Sustainability in managing backlogs.
 - Capacity building of staff by freely attending envisaged trainings without much concern on case backlog.

F. Sustainability of the Project impact after the Project Completion

According to the National Strategy for Transformation(NST1) of the government of Rwanda of 7 years (2017-2024) and the Justice Sector Strategic Plan of 2017-2024, Rwanda justice is strategically positioned to contribute towards priority areas of economic transformation; transformational governance (strengthening Justice, Law, and Order, and hold people and government accountable to the respect of fundamental liberties and human rights by improving *access to timely and quality justice services*).

To achieve this, NPPA will use the following strategies to close the backlog both at NPPA and in criminal courts:

• Plea bargaining:

A plea bargain is an agreement between a defendant and a prosecutor, in which the defendant agrees to plead guilty or "no contest" (nolo contendere) in exchange for an agreement by the prosecutor to drop one or more charges, reduce a charge to a less serious offense, or recommend to the judge a specific sentence. From this definition, it is evident that if defendants enter into a plea bargain with prosecutors, then prosecutors will earn more time than what they used to spend in courts arguing with defendants hence allow them to concentrate on other tasks.


• ADR/Mediation:

The term "alternative dispute resolution" or "ADR" is often used to describe a wide variety of dispute resolution mechanisms that are short of, or alternative to, full-scale court processes. The term can refer to everything from facilitated settlement negotiations in which disputants are encouraged to negotiate directly with each other prior to some other legal process, to arbitration systems or mini-trials that appear much like a courtroom process. By using mediation, many cases will be solved out of court, hence contributing to a significant reduction of the number of cases going before criminal courts and this will not only reduce the backlog in courts but also will save more time for prosecutors which will be used on the most serious cases that need to be litigated before the court.

- Reinforcement of Fines payment: In Rwanda, the fine as the main penalty applicable to natural persons is governed by Law No 068/2018/OL of 30/08/2018 providing offences and penalties in general. The amount of a fine for different offenses is provided in the Penal Code. In some instances, a fine is the only possible penalty for a given offense, in others, there is an option to order the convict to pay a fine or to sentence him/her to imprisonment while in others a fine comes as an addition to imprisonment. The application of fines as stipulated in the code of criminal code will allow the prosecution to close many cases to which fine is the penalty without necessarily going to courts hence saving more time for other cases that are meant to go before courts.
- **Bail:** Bail is defined as a set of pre-trial restrictions that are imposed on a suspect to ensure that they will not hamper the judicial process. It is also understood as the conditional release of a defendant with the promise to appear in court when required. Bail is recognized under the Rwandan code of criminal procedure of 2019 and was extended to all the crimes which was not the case for the previous Criminal Procedure code of 2013. In case bail is accepted, there is no need for the pretrial detention which has also been consuming prosecutors time not only this but also the use of bail will significantly reduce the prison overcrowding.
- Electronic Indictments: This is a new NPPA innovation that is intending to speed up the use of IECMS by prosecutors while filing criminal cases and it will definitely save precious amount of time that used to be spent while working on ordinary indictments.
- It is very crucial to mention that *the Prosecutor General has published instructions on the use of plea bargaining, mediation, and bail.* These instructions will help prosecutors to reduce the number of cases pending in courts because they will have the flexibility to implement them out of courts alternatives and hence contribute to timely and quality access to justice as a core pillar in the justice sector strategic plan.

- With the above-mentioned alternatives, it will ensure the sustainability of the impact of the SPIU project even after its phase-out, with regard to the contractual prosecutors, they are going to help NPPA to avoid the backlog as we start implementing these alternatives to limit the number of new cases creating backlog at both NPPA and Criminal Courts level.
- The NPPA annual report of 2019-2020 shows 59.7% of files received were sent to courts and the quarterly report of 2021-2022 shows that 58% were sent in courts, this is implying a decrease of 1.7% of files being sent to courts in just one quarter. It is in this spirit that NPPA wishes to continue implementing the above mentioned strategies to make sure that a more significant decrease is achieved because the focus is in making sure that many cases are solved using out of courts modes of settlement.
- The hired contractual staff will facilitate in managing backlogs but also support in NPPA in its current effort to use alternatives to dispute resolution that will help in reducing the probable increase of cases to deal with in addition to significant reduction of the case backlog that courts are grappling with at the moment which affects the criminal justice chain in execution of its duties. As a result, quality of justice will be enforced as well as ensuring fair trial rights and speedy justice for defendants.

CONCEPT PAPER ON HIRING CONTRACTUAL JUDGES AND REGISTRARS

I. INTRODUCTION AND BACKGROUND

The Judiciary of Rwanda has a vision of providing timely and quality justice. Since the judiciary reform of 2004, major efforts were put in to meet this vision. As now, tangible results were achieved in terms of improved speed of processing cases and quality of judgements. However, the Judiciary still faces challenges in term of quality judgements, mainly due to persisting case backlogs in Court. Having a big number of backlogs delays justice but also put more pressure on Judges and Registrars. When their workload is so heavy, it impacts the quality of judgement as they do not have sufficient time to analyse their cases.

In this contest, the SPIU of Supreme Court has hired 15 Legal Researchers and 1 International Experienced Researcher but case backlogs are continuing in Primary Courts, Intermediate Courts, High Court and Court of Appeal. One of the recommendations adopted in Steering Committee Meeting of 20th October 2022 was to seek for technical assistance from the lowest courts to the highest as a most successful strategy as it has been experienced from 2012 to 2016 with the assistance of UNDP and EU. Therefore, hiring temporary contractual Judges and Registrars to deal with backlogs will be a good response.

A portion of 5.1.2a from contingencies budget line will be used due to the insufficient funds from balanced budget lines mentioned above. Non-Objection is needed from Donors to cover all costs related to the hire of new temporary Judges and Registrars.

V. AREAS OF FOCUS

20 Judges and 20 Registrars recruited in Primary Courts will replace their workmates. Only 5 judges and 5 registrars will be considered as an added value in Primary Court Level. 10 Judges and 10 Registrars will be considered as added value in Intermediate Court level and the remaining 5 Judges and 5 registrars will be an added value in High Court Level.

The Budget of the project can't cover the top-ups of Judges and Registrars' salaries transferred to Highest Courts but it can cover monthly transport allowances from their regular posts of services to the future located courts.

The new temporary Judges and Registrars will be remunerated through the budget of Single Project Implementation Unit of Supreme Court. Budget will contain the following features

VII. EXPECTED OUTCOME

Judges and Registrars recruited will play a great role on reduction of cases backlog. From Primary Court up to High Court, every judge can render at least 15 judgements per month. 20 Judges and 20 registrars recruited will be placed in Primarily Courts. The 5 Judges and 5 Registrars added to the Primarily Court's staffs will render 1500 judgements in 20 months.

In Intermediate Courts, 10 Judges and 10 Registrars added from Primary Courts will render 3,000 judgements in 20 months.

In High Court levels, 5 judges and 5 Registrars added from Intermediate Courts level will render 1,500 judgements.

In brief, through the hiring of temporary judges and registrars, 6,000 cases will be rendered in 20 months.


