I am pleased to inform you that your application has successfully passed the evaluation. Your proposal may be funded under rescEU, provided that the adjustments described below are made.

First of all, please find below the summary conclusions of the evaluation of your application.

The proposal has been assessed positively against the technical and financial aspects set in the conditions for application and has obtained a score of 73 out of 100 with regard to the award criteria.

The quality of the intensive care equipment to be procured appears to meet the minimum standards laid down in Commission Implementing Decision (EU) 2020/414. The indicated timeline to develop the capacity is appropriate to build up a strategic rescEU stockpile and the described stock management system seems efficient and sustainable. Furthermore, the deployability of the capacity is ensured.

Based on the aspects outlined above, the following corrections and adjustments need to be introduced in your proposal.
