Definitions

- **Passenger Name Record (PNR):** PNR data is information provided by passengers and collected by air carriers for enabling reservations and carrying out the check-in process. It is a record of each passenger's travel requirements held in carriers' reservation and departure control systems. It may contain a wide range of information, such as first and last name, DOB, dates of travel, travel itinerary, ticket information, contact details, travel agent, means of payment, seat number and baggage information.
- **Advance Passenger Information (API):** API information usually consists of data found in the Machine Readable Zone (MRZ) of passports and other travel documents (full name, date of birth, gender, passport number, country of citizenship, country of passport issuance). It is collected during check-in and boarding time.
- **TRavel Information Portal (TRIP):** Software system created by the Dutch government, used as a Single Window by air carriers for providing PNR/API data.


Discussions and points raised

- The OICT team presented a brief introduction of its Software Products for Member States (unite.un.org/goportfolio), highlighting the standard operating procedures followed in deploying its software solutions directly in Member States jurisdictions.
- The goAML (Government Office Anti Money Laundering) software solution shares commonalities with the TRIP system in terms of use cases and technical architecture.
- The OICT team shared its experiences gained from deploying software products for Member States for almost 15 years, including deployment setup and cost models for software support.
- The Dutch team presented a brief history of the implementation of the travel intelligence instrument for CT and organized crime purposes (incl. TRIP system) both from technical and political and legislative

perspective spanning almost 5 years (from PNR-related decisions: the Directive (EU) 2016/681 and the UN Security Council resolution 2396)

- The Dutch team shared the importance of addressing the full spectrum in the implementation of passenger information. This can be translated into four pillars that provide adequate and sustainable use of the instrument, being legal, governance, operational and technical (including carrier engagement). A system like TRIP cannot be used in isolation and must be underpinned by the other pillars (and the other way around).
- The Dutch team shared deployment and operational practices as well as lessons learned from using the TRIP system in The Netherlands. The importance of a dedicated multi-disciplinary team with sufficient mandate and financing was underlined.
- The Dutch team introduced the structure and the operation of the Informal Working Group on PNR (established by the Dutch team). The purpose of the working group is to collect experts from various countries and discuss PNR-related challenges.
- The Dutch team shared its future plan for collecting PNR and API data also from bus, train and maritime carriers.
- The Dutch team expressed future requirements for enriching the PNR data based on information collected from travel agencies and tour operators.
- The Dutch team emphasized the importance of managing a good relationship with air carriers in order to establish smooth and reliable PNR/API data exchange.




Figure 1- TRIP System Architecture Diagram

- The Dutch team explained the system architecture of the TRIP (see Figure 1 in appendix) and showcased the software.
- The main TRIP system use cases cover:

- Besides the TRIP system, the Dutch team developed two additional software systems:

- By transferring the source code from the Netherlands to UN the UN could work on a “blue flag” central code base to support countries. In the current situation a country can receive the source code (e.g. the Dutch code base) from the Netherlands but each country is required to have it’s own developers for maintaining the countries code base.

- The Dutch team also shared its current model on PNR data exchange: the Passenger Information Unit (PIU) operates the TRIP system, and competent authorities can request the PIU to setup filters and watchlists on the PNR data.

- The Dutch team is working at building [REDACTED] order to support Passenger Information Units (PIUs) in prevention, detection, investigation and prosecution of terrorist offences and serious crime at international level.
- The Dutch team shared its current technical team structure. The overall team is a collection of dedicated experts on the other pillars, including legal councils, political strategy/policy, programme director, carrier engagement officers and governance/finance, and technical experts. For operating the TRIP system for the Netherlands, the following technical resources are currently in place: [REDACTED]

- The Dutch team explained the reason why they approached the United Nations regarding the TRIP system: the NCTV does not have the resources to deploy the TRIP software for other governments. On the other hand, the NCTV is willing to share with others both their experience and knowledge on the implementation of PNR/API instrument in the CT and organized crime area and the software solution for handling PNR/API data.
- The Dutch team sees the United Nations as a great candidate for taking over the TRIP system and deploy it for Member States.
- Currently OICT doesn’t have budget and resources to work on a “UN TRIP system”. If budget and resources will be made available it’s necessary to secure that knowledge and experience of the NCTV subject matter experts is available for OICT. It’s import to have a budget and governance structure for the first 3-5 years to avoid problems on investments and delivery of services to countries showing interest in UN TRIP or countries already running UN TRIP.
- Suggestion would be to also investigate possibilities around carrier connection. This could make the implementation in a countries much easier and faster and would be very beneficial for carriers.

Dear Colleagues and our Distinguished Donors,

To follow up on the informative coordination call we had on 13 June on the potential transfer of the TRIP system from the Netherlands to the UN, we would like to invite you to a VTC to take place on **Tuesday, 19 June from 9:30 to 11:30 am New York time**.

As we are in the midst of negotiating this generous offer of the Government of the Netherlands, we would like to ensure coordination and a successful consultative process as the transfer involves some technical and legal aspects. To this end, and to provide an overview and summary of the current state of affairs, we hope it would be useful to consult each other prior to the signing of Letter of Intent (LoI) during the High-Level Conference .

The immediate next step is the finalization of the draft LoI, to be signed during the High-Level Conference by the National Counter-Terrorism Coordinator of the Netherlands and Under-Secretary-General Voronkov. Our colleagues in OLA have shared the updated draft of the LoI with us. It is currently under review and we will deliver a draft for your consideration by 11 am on Tuesday, 19 June.

On the basis of the LoI, and further consultations and negotiations, we hope to conclude an agreement on the transfer of the TRIP system to the UN, to be signed by the Secretary-General and the Prime Minister of the Netherlands during the high-level segment of the General Assembly in September. To allow our colleagues from OLA to familiarize with some technical details of the TRIP software, it would be useful to hold the VTC mentioned above. This would allow the technical experts to provide an in-depth briefing to the legal experts. Our Office would benefit from this knowledge as well.

Should you be available, we would be grateful if you could kindly inform Ms.

_____@un.org, of your availability and your VTC connection details by **Monday, 18 June, 9:00 am New York time**. Specifically, we would appreciate it if you could provide your _____ number as well as the **name, telephone number, and email address of your technician**. 5.1.2e



Background

The Travel Information Portal (TRIP) system consists of software and associated artifacts (processes, source code, libraries, configuration, documentations etc.) to develop, support and manage development and production systems developed by the Dutch government.

It is assumed that the Dutch TRIP system's source code, including licensing, will be transferred to the UN with the understanding that the UN will not only configure and adopt the code, but also undertake an in-depth analysis to ensure that it is reliable, scalable and free from any security-related threats.

To this end, this document is aimed at facilitating transfer of the TRIP system to the UN, Office of Information and Communications Technology (OICT). It describes artefacts that are required to develop, adopt, build, operate and continuously enhance the TRIP system.


It is also proposed to transfer the [REDACTED]. The TRIP System has interface to [REDACTED] which allows to execute query data in other connected countries via a secured network. The result of query indicates whether there is a hit or no hit. All transfer producers describe in this document are also application to [REDACTED].

Assumptions

Due to the lack of detailed design documents and requirement specifications, this document attempts to describe the system with the knowledge gained by the UN team visiting the site, examining the system, reading high level documentation and taking part in a presentation made by the Dutch team. As a result, the following assumptions are made:

- Dutch team will indicate any mistake or missing information in this document.
- Dutch Team will continue to extend assistance during the transition period. The transition period is defined as the period of time after the transfer of artefacts described in this document and verification of a designated UN staff to independently build and deploy a production version of the system close to that of the Dutch TRIP system.
- Dutch government will provide the full right to modify and own the source code and artefacts by the UN. Any modification including transferred artefacts done by UN will also become property of the UN.
- Dutch team will provide existing Service Level Agreement (SLA) for the system and pertinent documents that describe the overall system and requirements even if only available in Dutch language.





Exploration paper: "Towards the international implementation of PNR"

Detection of terrorists; a current and future challenge

ISIS has suffered several setbacks in the Syrian Arab Republic and Iraq. As a result of these setbacks, ISIS was forced to evolve to a networked group, emphasizing terror attacks within and outside the original conflict zone. The result is a new and emerging global network of ISIS and Al-Qaida affiliates. In response to these new developments, the UN Security Council, acting under Chapter VII of the UN Charter, unanimously adopted resolution 2396 on the 21st of December 2017. With the adoption of this resolution, the Council actively expressed its concern that foreign terrorist fighters (FTFs) and their families may be seeking to return to their countries of origin or to relocate to third countries to foster radicalization and to support or perpetrate terrorist acts. For the detection of these movements, the use of Passenger Name Record (PNR)¹ is essential. With resolution 2396 (reflected in paragraph 12), the collection, processing, analyzing of PNR data, as well as the sharing of these data has now become an international obligation, an essential step in the fight against terrorism. This obligation is a first step; putting in practice the use of PNR for the detection of unwanted travel movements by terrorists or criminals is the next challenge.

The Council "12. Decides that Member States shall develop the capability to collect, process and analyse, in furtherance of ICAO standards and recommended practices, passenger name record (PNR) data and to ensure PNR data is used by and shared with all their competent national authorities, with full respect for human rights and fundamental freedoms for the purpose of preventing, detecting and investigating terrorist offenses and related travel, further calls upon Member States, the UN, and other international, regional, and subregional entities to provide technical assistance, resources and capacity building to Member States in order to implement such capabilities, and, where appropriate, encourages Member States to share PNR data with relevant or concerned Member States to detect foreign terrorist fighters returning to their countries of origin or nationality, or traveling or relocating to a third country, with particular regard for all individuals designated by the Committee established pursuant to resolutions 1267 (1999), 1989 (2011) and 2253 (2015), and also urges ICAO to work with its Member States to establish a standard for the collection, use, processing and protection of PNR data

Collecting PNR using TRIP

Cross-border crime, terrorism and smuggling continue to be a major and worldwide cause of concern. More and more governments seek to improve their ability to detect and combat these crimes. Different countries are currently in the process of improving the detection of travel movements in the area of counter-terrorism, within the context of the European Union due to the API Directive

(2004/82/EC), the Union Customs Code and the PNR Directive. Following up on these requirements, the Netherlands has, during its EU Presidency, developed a system called Travel Information Portal, or TRIP. TRIP is a technical facility for the collection and processing of travel data. TRIP provides a single, centralised information portal to which airlines send the travel data. TRIP makes use of the so-called 'push' method: airlines transmit ("push") the required data to TRIP. TRIP has the ability to process the information and, when necessary, actively send a signal to relevant parties (to be determined by governments themselves) for instance customs or the police in case of unwanted travel movements. This is in line with international developments in passenger data exchange between the aviation sector and governments².

The Kingdom of the Netherlands acknowledges that developing and operationalizing PNR can be timely and costly. This was also acknowledged in paragraph 48 of resolution 2396:

The Council 48. Notes that the implementation of aspects of this resolution, especially PNR and biometric data collection, can be resource-intensive and take an extended period of time to develop and make operational;

For this reason, the Netherlands has already transferred TRIP to various countries around the world, namely European partners. Via the transfer of the TRIP system, including its source code, as well as the expertise surrounding it, the period of time and expenses to develop and operationalize PNR, could be reduced significantly. This is of vital importance to national and international security.

Working together towards the international implementation of PNR: Dutch offer

To achieve an international, correct and effective implementation of PNR in line with the obligation in resolution 2396 and in full respect for human rights, the need for the United Nations (UN) to fulfil a key role is of evident necessity. The Netherlands can pay a substantive contribution to the implementation of PNR via the offer to make TRIP system available to the UN for a worldwide implementation.

Strong political commitment of the UN, in particular of the Office of Counter-Terrorism (OCT), CTED

The Council 14. Encourages improved cooperation between ICAO and CTED, in coordination with other relevant UN entities, in identifying areas where Member States may need technical assistance and capacity-building to implement the obligations of this resolution related to PNR and API and watch lists.

and ICAO, is required as reflected in resolution 2396.

Merely the transfer of the TRIP software will not be sufficient for a successful implementation of the PNR requirement in resolution 2396. Additional steps need to be taken to facilitate implementation on a global scale. A transfer of expertise on the functioning and requirements for the use of the software is conditional and of equal importance. On top of offering the software itself, building capacity to establish the correct expertise for the use and implementation of the system itself is necessary. Such capacity building would require financial support from others as well and involvement of the UN.

Next steps

The Netherlands invites interested parties to start a dialogue and further explore possibilities for cooperation.

The information concerns reservation information (PNR) and departure control information (API). This applies to all Dutch airports and only for non-EU and non-Schengen flights.



What will change?

Many air carriers already provide the Royal Netherlands Marechaussee with API for inbound flights. A new aspect is that PNR for both inbound and outbound traffic must also be submitted to a single central point. This working method is in line with international developments for data exchange between the aviation sector and government authorities.

The data transfer is subject to the international standards as formulated by the

International Civil Aviation Organisation (ICAO), the World Customs Organisation (WCO) and the International Air Transport Association (IATA):

- UN/EDIFACT PAXLST for API
- UN/EDIFACT PNRGOV for PNR

Retention period

For Customs, PNR is stored in TRIP for two days. In specific cases, this period will be 30 days. After this period, the personal data are destroyed and the other data are forwarded

to the Customs systems. This anonymous information is used for trend analyses, for example.

API is forwarded to the Marechaussee's API centre and does not remain stored in TRIP.

Privacy

Air carriers inform their passengers of the fact that they provide travel information to the authorities. The websites of Customs and the Marechaussee show which information is collected for which purpose.

The data exchange is governed by the Personal Data Protection Act (PNR) and the Police Data Act (API). The TRIP system is subject to strict security measures in order to safeguard the privacy of passengers.

Advantages

The number of direct requests for information to air carriers that automatically provide data is expected to decrease, which saves time and money. Moreover, improved information allows organisations such as Customs to work

more specifically, thereby reducing delays in the departure and arrival process as much as possible. After all, we all benefit from a safe and smooth flow of passengers and goods.

General

What is the Travel Information Portal?

The Travel Information Portal (TRIP) is a technical facility for the collection of travel data which the Customs Administration of The Netherlands and the Royal Netherlands Marechaussee must have at their disposal on the basis of their statutory powers. TRIP also makes it possible to consult travel data by automated means to execute a request from a public prosecutor.

The travel data consist of reservation and departure control data, also respectively referred to as *Passenger Name Records* (PNR) and *Advance Passenger Information* (API). PNR are recorded by the airline for every passenger who books a flight and include such items as the date the reservation was made, contact details, luggage information and any check-in or boarding information available. API are data from the travel document (such as name and nationality), about the flight (such as the flight number and time of departure) and about the travel route. The exact set of API data is laid down in Section 2.2a subsection 3 of the Aliens Decree 2000.

What is the purpose of TRIP?

The first purpose of TRIP is to create a *Single Window* function for the supply of travel data by civil aviation, in order to support :

- the statutory control and supervision tasks of Customs with regard to the cross-border movement of goods;
- the statutory tasks of the Royal Netherlands Marechaussee with regard to border control and combatting illegal migration;
- reducing the administrative burden on airlines.

The second purpose is to create an *application* which:

- allows Customs to scan flights for risk indicators in preparation for targeted inspections;

- supports the automated execution of a request from the public prosecutor to obtain information about a passenger in connection with a criminal investigation.

What has changed?

TRIP provides a *Single Window* (a single, centralised information portal) to which airlines send the travel data required by Customs, the Royal Netherlands Marechaussee and the public prosecutor in the exercise of their statutory powers.

A number of airlines already supply API data to the Royal Netherlands Marechaussee. In future these data will be delivered to the API centre of the Royal Netherlands Marechaussee by means of TRIP. Airlines will now also supply the PNR data to Customs via TRIP.


TRIP has adopted the '*push*' method: airlines transmit ("push") the required data to TRIP. This is in line with international developments in passenger data exchange between the aviation sector and governments (*Guideline on PNR Data ICAO 2010, doc 9944*).

Thanks to the automated supply of data by airlines, the number of 'manual' requests addressed directly to airlines by authorised bodies will decline. Because data are only retained in TRIP for a short period of time, it will still be necessary to request historical information directly from the airline (always based on a request from the public prosecutor).

For which countries of departure and arrival are the travel data required?

The airlines from which Customs requires data must supply these for all flights departing outside the European Union landing at a Dutch airport and for all flights departing from a Dutch airport to destinations outside the European Union.

API data must be supplied for flights to the Netherlands from the airports listed in Appendix 1a of article 2.1a of the Aliens Regulations 2000.



Legal aspects

What is the legal context of the introduction of TRIP?


Customs is authorised to request and use PNR data pursuant to Sections 13, 14 and 15 of the Community Customs Code (CCC) and Section 1:32 of the General Customs Act.

Airlines are obliged to collect and provide API data pursuant to the Aliens Act 2000 (Section 4 third subsection), the Aliens Decree 2000 (Sections 2.2a, 2.2b and 2.2c) and the Aliens Regulations 2000 (Section 2.1a).

In executing a request from the public prosecutor, authorities may request passenger data from Customs and the Royal Netherlands Marechaussee in the Travel Information Portal (on the basis of Sections 126nd and 126ne of

the Code of Criminal Procedure for example). At present authorities turn to the airlines directly in execution of those requests, or to the API centre of the Royal Netherlands Marechaussee.

TRIP also takes, as far as possible, the forthcoming European Directive regarding the use of PNR data into account. (*Proposal for a Directive of the European Parliament and the Council regarding the use of the personal data of passengers for the prevention, detection, investigation and prosecution of terrorist offences and serious crime.*)



Privacy

How is the privacy of travellers guaranteed?

The processing of travel data by Customs takes place in accordance with the Personal Data Protection Act. The processing of API data by the Royal Netherlands Marechaussee takes place in accordance with the Police Data Act and the Aliens Act 2000. 'Privacy Impact Assessments' are carried out in the context of the implementation of TRIP to ensure that the statutory obligations associated with those Acts are complied with.

Passengers may submit a request to the airline to inspect their personal data and correct it if necessary. They may submit a similar request to the Royal Netherlands Marechaussee or to Customs.

How long are personal data retained?

The PNR data are retained by Customs in TRIP for 48 hours, or for 28 days in the case of targeted investigations. After this period the *personal* data are deleted. The remaining data is sent on to the systems operated by Customs, who then use it for trend analysis.

The API data sent to TRIP for the Royal Netherlands Marechaussee are sent on to the API centre within one minute. These data are not retained in TRIP.

How are travellers informed of the fact that travel data are passed on?

Airlines must inform their passengers of the fact that travel data are passed on to the authorities. Customs and the Royal Netherlands Marechaussee also give a full account of the nature and purpose of the collected data on their websites.

Technology and processes

How do airlines send data to TRIP?

Airlines supply the requested PNR and API data to TRIP using a secure connection (possibly by way of a third party). The connection runs through *ebMS* (*ebXML Messaging Service*), a protocol for secure and reliable messaging between two parties. ebMS is the protocol recorded in the central government standard for data linkage known as *DigiKoppeling*.

For the purposes of data transfer the standards formulated by the ICAO (International Civil Aviation Organisation), the WCO (World Customs Organisation) and the international interest group for airlines IATA (International Air Transport Association) are applied.

For API data the applied standard is *UN/EDIFACT PAXLST* and for PNR data the applied standard is *UN/EDIFACT PNRGOV*.

How is the connection set up between an airline and TRIP?

At the start of the connecting process an intake interview takes place between the specialists of TRIP and the airline concerned. During this interview the (technical) implications of supplying the data are clearly explained, as well as the legal basis. A joint plan of action for the technical connection is then drawn up. It is subsequently verified, by means of a number of test deliveries, that the correct data are being supplied and received securely, and in the right format. Only then does the connection go 'live'. From that moment on the airline's travel data are sent to TRIP in an automated fashion.

An agreement is drawn up between the airline and the requesting party (Customs for example), describing how parties will deal with each other. The Ministry of Security and Justice is responsible for the technical and functional management of TRIP.

Can airlines use a broker to send data?

Airlines may decide for themselves whether they will supply data to TRIP directly from their own systems, via a *Global Distribution System* (GDS) such as

[redacted]. In all cases the airline remains responsible for supplying the requested data.

Consequences for airlines

What are advantages to the airlines of implementing TRIP?

Connected airlines will supply the required travel data to a single portal (TRIP Single Window). It is also expected that the number of information requests sent directly to the airline will decline. This will save time and

money. The privacy of the passengers of the airlines is well protected since the airlines do not know the identity of the persons for whom data is requested on behalf of the public prosecutor.

Are the airlines obliged to supply new data?

No PNR data is requested other than what is already present in the reservation and departure control systems of the airline concerned. Airlines are not obliged to collect PNR data.

API is a fixed set of data which must be collected by the airline and delivered in full.

Are the airlines held responsible if the information sent turns out to be incorrect or incomplete?

Airlines have a statutory obligation to supply, on request, *all* the PNR data at their disposal to a legally authorised party such as Customs. Airlines are not held responsible for the correctness of that data.

API data on the other hand can be verified. Pursuant to Section 4 of EU Directive 2004/82, necessary measures and sanctions are imposed on carriers who provide incomplete or incorrect data through attributable negligence.

How often and at what moments should airlines pass on ('push') the requested data?

The following applies for the supply of travel data:

API: One-off transmission within 15 minutes of 'off blocks' (the moment at which the aircraft leaves the gate). If it is easier for the airline to send the information twice (once after check-in and once after departure of the aircraft from the gate) this is also permitted.

PNR: for the proper exercise of its tasks Customs has defined the following *push* moments for PNR data ('T' being time of departure):

- Inbound flights: T-72 hours, T-24 hours, T-30 minutes and 15 minutes after departure;
- Outbound flights: T-24 hours, T-75 minutes, T-1 hour, T-45 minutes and 15 minutes after departure.

Are there costs for the airlines associated with supplying the travel data?

Costs may be incurred by the airline in question when supplying API and PNR data if, for example, a third party is deployed to pass on the messages on behalf of the airline. The level of these costs will depend on such things as the number of flights operated by the airline to and from the Netherlands (and therefore the number of messages). The airline must bear the costs of supplying the travel data. It is however anticipated that airlines will also save costs because fewer requests for data will be coming in directly. This will reduce the amount of (manual) work involved, thereby saving time and money.

Will an interactive API (iAPI) system be introduced?

Interactive API, whereby the airline can ascertain in advance of departure whether or not it can take a passenger on board, is not a component of TRIP at the present time. It may well become part of the functionality provided in the future however.

Is the airline responsible for returning passengers who have been refused at the border and/or is there a fine to be paid in this regard?

The airline remains responsible for its passengers. If a passenger is refused at the border (whether or not on the basis of the travel data supplied by the airline) it remains the responsibility of the airline to take that passenger back to the country of origin, and to accept the associated expense for its own account.

International developments

How does TRIP tie in with international developments?


Cross-border crime, terrorism, illegal immigration and smuggling continue to be a major, worldwide cause of concern. More and more governments are seeking to improve their access to information to help them to detect and combat these crimes. Supply of travel data by airlines is an important tool in this regard.

Within the context of the European Union this development is evinced by the API Directive (2004/82/EC), the *Union Customs Code* and the forthcoming PNR Directive.






What is a CPA?

Example CPA



1. Introduction

The purpose of this PNR Implementation Guide is to provide the necessary information to carriers and their (data transmission) service providers for complying with the Dutch government's PNR requirements.

Carriers are required to provide reservation (PNR) and check-in and boarding (API) data of all passengers for all flights to and from airports in the Netherlands.

This Guide sets out to explain the legal basis for this, the principles of operation of the Dutch Passenger Information Unit, which information is specifically being requested and which implementation steps carriers need to follow in order to be in compliance.

2. Provision of PNR data in the Netherlands

2.1 Legal basis

EU PNR directive

The legal basis for requesting PNR data from the carriers can be found in Directive (EU) 2016/681 of the European Parliament and of the Council of 27 April 2016 on the use of passenger name record (PNR) data for the prevention, detection, investigation and prosecution of terrorist offences and serious crime.

The full text of the Directive (in multiple languages) may be found here: <http://eur-lex.europa.eu/legal-content/EN/TXT/?uri=CELEX:32016L0681>

The Directive is foreseen to be transposed into Dutch national law in the first quarter of 2018. From that date onwards the legislation is applicable to all carriers flying to and from the Netherlands.

Relation with existing legislation

The transposition of the PNR Directive does not prejudice the existing legal obligations regarding the provision of passenger data by air carriers.

The Customs Administration of the Netherlands is authorized to request, consult and use PNR data pursuant to Articles 15 and 46 of the Union Customs Code and Article 1:32, paragraph 2, of the Netherlands General Customs Act.

Air carriers are obliged to collect and provide API data pursuant to the Aliens Act 2000 (Article 4, paragraph 3), the Aliens Decree 2000 (Article 2.2a, 2.2b and 2.2c) and the Aliens Regulations 2000 (Article 2.1a).

In executing a request from the public prosecutor (based on the Netherlands Code of Criminal Procedure), competent authorities such as the National Police may also directly request passenger data from an air carrier.

Single Window

In order to minimize the administrative burden on carriers a *Single Window* has been created by the Dutch government to which the carriers may send the requested data. This means that in case the same data (at the same 'push moment') is requested from an air carrier by different governmental organizations, carriers can send these data *only once*.

For example: both Dutch Customs and the PIU-NL request PNR data to be sent immediately after flight closure (see paragraph 3.2 for Push moments). The carrier sends this data to the Single Window *once*; the Single Window then distributes the data to Customs and PIU-NL in accordance with their respective legal mandates.

2.2 Passenger Information Unit Netherlands (PIU-NL)

The Passenger Information Unit Netherlands (PIU-NL) is responsible for:

- Collecting PNR data from air carriers, storing and processing those data and transferring those data or the result of processing them to the competent authorities
- Exchanging both PNR data and the result of processing those data with the PIUs of other Member States and with Europol.

The PIU-NL processes PNR data for the following purposes:

1. Carrying out an assessment of passengers prior to their scheduled arrival in or departure from the Netherlands to identify persons who require further examination by the competent authorities, and, where relevant, by Europol, in view of the fact that such persons may be involved in a terrorist offence or serious crime;
2. Responding, on a case-by-case basis, to a duly reasoned request based on sufficient grounds from the competent authorities to provide and process PNR data in specific cases for the purposes of preventing, detecting, investigating and prosecuting terrorist offences or serious crime, and to provide the competent authorities or, where appropriate, Europol with the results of such processing; and
3. Analyzing PNR data for the purpose of updating or creating new criteria to be used in the assessments in order to identify any persons who may be involved in a terrorist offence or serious crime.

When carrying out the assessment referred to under point 1), the PIU-NL may:

- Compare PNR data against databases relevant for the purposes of preventing, detecting, investigating and prosecuting terrorist offences and serious crime, including databases on persons or objects sought or under alert, in accordance with Union, international and national rules applicable to such databases; or
- Process PNR data against pre-determined criteria.

Any assessment of passengers prior to their scheduled arrival in or departure from the Netherlands carried out against pre-determined criteria is carried out in a non-discriminatory manner. The pre-determined criteria are targeted, proportionate and specific.

2.3 Data protection

The PIU-NL appoints a data protection officer responsible for monitoring the processing of PNR data and the implementation of relevant safeguards. A data subject has the right to contact the data protection officer, as a single point of contact, on all issues relating to the processing of that data subject's PNR data.

The PNR data provided by the carriers to the PIU-NL are retained in a database at the PIU-NL for a period of five years after their transfer. The PNR data are deleted permanently upon expiry of this period. Upon expiry of a period of six months after the transfer of the data, all PNR data shall be *depersonalized* through masking out the data elements which could serve to identify directly the passenger to whom the PNR data relate. Disclosure of the full PNR data shall then only be permitted where it is reasonably believed that it is necessary for the preventing, detecting, investigating and prosecuting of terrorist offences or serious crime and the request is approved by a judicial authority.

The processing of PNR data revealing a person's race or ethnic origin, political opinions, religion or philosophical beliefs, trade union membership, health, sexual life or sexual orientation is prohibited. It is requested to *not* send this type of PNR data to the PIU-NL. In the event that PNR data revealing such information are received by the PIU-NL, they shall be deleted immediately.

Every passenger has the right to protection of their personal data, rights of access, rectification, erasure and restriction and rights to compensation and judicial redress. Carriers involved should ensure that passengers are clearly and precisely informed about the collection of PNR data and their rights.

2.4 Sanctions

Failure to comply with this notification of requirements may lead to sanctions, as specified under Dutch law.

Air carriers are obliged to transfer the PNR data that they already collect in their normal course of business. This therefore concerns a delivery obligation and not an obligation to collect. In case an air carrier does not meet her obligations under or pursuant to the PNR law, violation thereof can be punished with a custody of a maximum of six months or a penalty of the fourth category (article 24 in the PNR law)¹.

In case an air carrier does not fulfill or incompletely fulfills her delivery obligation, she will be addressed by the Pi-NL. In case this occurs more often or structurally, the air carrier will receive an official warning from the Pi-NL. After this first warning an air carrier has seven days to send the complete information. From the moment of the first warning, a trial period of 90 days will start. In case in these 90 days all data is being received correctly, the trial period will end. However, in case in this period the data is still incomplete or not received, a new seven-day period will start to fulfill the obligation and the airline will receive a second warning. If the Pi-NL establishes that during the trial period an air carrier does not fulfill her obligations for a third time, an official report is drawn up. This official report will be forwarded to the Public Prosecution service, together with the earlier warnings, who may decide on sanctioning.

¹ This is published in the Staatscourant. The Staatscourant includes all of which a law, royal decree or ministerial order prescribes publication or communication in the Staatscourant and publications originating from the central government.

3. Transmission of PNR

3.1 Scope of data to be transmitted

'PNR' means a record of each passenger's travel requirements which contains information necessary to enable reservations to be processed and controlled by the booking and participating air carriers for each journey booked by or on behalf of any person, whether it is contained in reservation systems, departure control systems used to check passengers onto flights, or equivalent systems providing the same functionalities.

Specifically, the following data is requested by the PIU-NL, as far as collected by the carrier:

1. PNR record locator
2. Date of reservation/issue of ticket
3. Date(s) of intended travel
4. Name(s)
5. Address and contact information (telephone number, e-mail address)
6. All forms of payment information, including billing address
7. Complete travel itinerary for specific PNR
8. Frequent flyer information
9. Travel agency/travel agent
10. Travel status of passenger, including confirmations, check-in status, no-show or go-show information
11. Split/divided PNR information
12. General remarks (including all available information on unaccompanied minors under 18 years, such as name and gender of the minor, age, language(s) spoken, name and contact details of guardian on departure and relationship to the minor, name and contact details of guardian on arrival and relationship to the minor, departure and arrival agent)
13. Ticketing field information, including ticket number, date of ticket issuance and one-way tickets, automated ticket fare quote fields
14. Seat number and other seat information
15. Code share information
16. All baggage information
17. Number and other names of travelers on the PNR
18. Any advance passenger information (API) data collected (including the type, number, country of issuance and expiry date of any identity document, nationality, family name, given name, gender, date of birth, carrier, flight number, departure date, arrival date, departure port, arrival port, departure time and arrival time)
19. All historical changes to the PNR listed in numbers 1 to 18.

The data described above should be sent for all flights to and from the Netherlands (including stop-overs / transfers). Exempted from this obligation are full cargo flights, military flights, evacuation flights and General Aviation (including business flights).

Where a flight is code shared between one or more air carriers the obligation to transfer the PNR data of all passengers on the flight is on the air carrier that operates the flight.

In the event that the carrier collects any advance passenger information (API) data listed under item 18 but does not retain those data by the same technical means as for other PNR data, the carrier shall transfer those API data to the PIU-NL in a separate PAXLST message.

This separate PAXLST message shall contain all data elements that are gathered by the air carrier in their normal course of business. If this indicates an air carrier collects baggage and seat information at check-in, the PAXLST shall be sent in 05B format to the PIU-NL. From our experience, most air carriers collect baggage and seat information at check-in, therefore consequently sending PAXLST 05B will fall under their delivery obligation. If an air carrier does not collect baggage and seat information at check-in, sending a PAXLST to the PIU-NL in 02B format is sufficient.

3.2 Data push moments

The PNR directive states that carriers shall transfer PNR data:

1. 24 to 48 hours before the scheduled flight departure time; and
2. immediately after flight closure, that is once the passengers have boarded the aircraft in preparation for departure and it is no longer possible for passengers to board or leave.

The Dutch government has established a Single Window in order to serve carriers as convenient as possible by alignment of push moments and reducing the number of push moments for the carriers to the Dutch government. Therefore, the push-moments for the Dutch Customs (extra EU-flights only) and for the PIU-NL will be aligned. The PNR push moments to Dutch Customs and PIU-NL are:

- Inbound and outbound : For extra-EU flights: pushes at T-48, T-24, T-1*, and at T=0 (immediately after flight closure)
- Inbound and outbound: For intra-EU flights: pushes at T-48, T-24, and at T=0 (immediately after flight closure)

Where access to PNR data is necessary to respond to a specific and actual threat related to terrorist offences or serious crime, air carriers shall, on a case by case basis, transfer PNR data at other points in time than those mentioned above, upon request from a PIU in accordance with national law.

3.3 Data format

For receiving the carrier's Passenger Name Records, the PIU-NL uses the message format **PNRGOV**, thus complying with the international standards as set out and agreed upon by ICAO, IATA and WCO (see also *Guidelines on Passenger Name Record (PNR) Data (Doc 9944)*). The PIU-NL accepts UN/EDIFACT PNRGOV version 11.1 to 13.1 and XML PNRGOV version 13.2.

In order to enable air carriers who collect check-in data, including API data, via a separate process or system the PIU-NL also supports the UN/EDIFACT PAXLST format.

Should you or your service provider not be familiar with these message formats, please refer to the *PNRGOV message implementation guide* and/or the *PAXLST Message Implementation Guide (05B)* available via <https://www.iata.org/iata/passenger-data-toolkit/library.html>

3.4 Transmission protocol

Carriers supply the requested data to the PIU-NL via one of the following transmission protocols (see Commission Implementing Decision (EU) 2017/759):

- IBM MQ;
- IATA Type B;
- AS4 Profile of ebMS 3.0 Version 1.0, OASIS Standard, published on 23 January 2013. Implementation of AS4 according to the e-SENS AS4 Profile developed by the e-SENS Large Scale Pilot, current identifier and version: 'PR - AS4 - 1.10'. As from 2017, the Connecting Europe Facility will continue to maintain and improve these implementation

Communications service provider (most widely used option)

The carrier may route the data through a communications service provider such as [REDACTED] 5.1.2.i

For both your test and your production environment you have to provide the filled out Connectivity Form as provided in Annex I. We will use this information for the creation of the Collaborative Protocol Agreement and for configuring our firewalls.

In Annex I you will also find further important technical details which you will need to establish a connection with the PIU-NL, such as the public key client and server certificates.

4. Implementation steps

The implementation steps for successfully sending the requested data to the PIU-NL are outlined below.



Depending on the technical solution or service provider a carrier chooses to deploy in order to establish the connection with the PIU, the carrier's previous experience with sending passenger information to government authorities and its familiarity with the data format, the full connection process takes circa six weeks up to three months.

4.1 Notification

The carrier's Board of Directors receives a formal notification from the Ministry of Security and Justice, outlining the carrier's legal obligations and the specific information it is requested to provide.

Once the notification has been sent, the PIU-NL Carrier Engagement & Connection team sends this Implementation Guide as well as a succinct info deck to the carrier's station manager for the Netherlands and establishes contact with him/her in order to initiate the connection process.

4.2 Pre-connection

In the pre-connection phase the carrier and the PIU team discuss the connection timeline and next steps to be taken. The carrier is requested to provide the following information:

- Contact details of carrier experts to be involved in the connection process
- Service provider(s) used (GDS and/or communication service provider)

- Availability of data (PNR and API)
- Technical characteristics of RES/DCS system(s) of carrier and/or service provider:
 - PNRGOV messaging already in place?
 - If yes, which PNRGOV version used for PNR?
 - Are RES and DCS integrated?
 - If not, how will API be transmitted? In which PAXLST version?
 - Full pushes or updated messages?
 - Multipart or single files?

After the requested contact details information have been received, the pre-connection phase ends with the kick-off meeting for the next steps: setting up connectivity and testing. In the kick-off meeting the carrier and the PIU-NL team discuss:

1. The information as provided by the carrier
2. Joint planning
3. Test scenarios
4. (Attendees and timing of bi-monthly conference call)

4.3 Set up connectivity²

In this phase all necessary preparations are made to connect the carrier or its service provider to the Single Window / PIU-NL. This may entail the collection of the required data from the carrier's database(s) and setting up the ebMS protocol for the data transfer. **Key information that the PIU-NL requires from the carriers for setting up the connection includes:**

More detailed information regarding establishing the data connection between the carrier and the Single Window may be found in Annex I: ebMS Connectivity Kit.

Please note that in case a communication service provider (such as [REDACTED] or a GDS is used to transfer the data to the PIU-NL, the carrier itself only has to establish the data connection (via any means of choice) to this service provider. In other words, when using a 3rd party, the carrier does not have to set up an ebMS connection. The carrier remains responsible however for the data transmission!

4.4 Testing

In the phase of testing, the mechanism of (re)sending data to the PIU-NL via the Single Window as well as the data itself is being tested. Key elements in this process are:

- Establishing a two-way connection (in test environment), using the agreed upon transfer protocol, where the PIU-NL receives a message and the carrier (or its service provider) receives a receipt acknowledgement
- Delivering messages for a week, based on the flight schedule
- Retry mechanism: During an agreed upon timeframe the carrier sends messages to the PIU-NL whilst the PIU-NL ebMS adapter has been shut down. The carrier's retry mechanism should then ensure that messages are resent a specific number of times and after specific intervals.
- Run test scenarios based on PNR data (various test scenarios for the different PNR data categories)
- Run test scenarios based on specific flight situations (eg. delayed flights).

More specifically:

Preparation of test process

1. Before the start of the testing phase the PIU-NL provides an overview of the test scenario's to the carrier
2. Carrier reviews all test scenario's and sends it back to the PIU-NL within the time span of 1 week
3. If the carrier cannot provide PNR data for a specific test scenario's, or the test scenario is not applicable to the carrier, the status of these test scenario's will be set to "not applicable" (NA) and a comment is added to the test scenario
4. During a conference call, if necessary, the test scenario's are discussed

Test process

5. The carrier creates a booking for a specific test scenario on a representative flight. Please note: a carrier may use the same booking (PNR-locator) for multiple test scenario's.
6. PIU-NL checks the PNR data against the information in the e-mail with the updated test scenario's and fills in column 'status PIU-NL'. In case of status 'NOK', the carrier will be informed and given feedback.
7. Carrier and PIU-NL discuss the test scenario's with status NOK and new test scenario's are created by carrier (step 5 – 7 are then repeated).

4.5 Approval and certification

Once the testing has been concluded successfully and the data integrity, the timing of push moments, the technical connection and security have been validated, the PIU-NL will supply the carrier with the Collaborative Protocol Agreement (CPA) for its Production environment, including endpoints and public keys. This is only applicable for carriers with AS4/ebMS protocol. The carrier will also receive a formal notification via email that testing has been successfully concluded and the carrier is certified to send production data.

Monitoring of the data (delivery) will continue in the production environment; to this end, contact details of the PIU-NL support organization and the relevant carrier contacts will be exchanged.

4.6 Account management

The carrier's and PIU's representatives will stay in touch in order to ensure continued complete and reliable data delivery.

The carrier should ensure that the PIU-NL is advised in a timely manner of any planned maintenance that could potentially interfere with data transmissions. This includes systems changes/upgrades, planned outages, etc.

In the event of an occurrence (eg. a flight lands in the Netherlands at an unscheduled airport or under unexpected circumstances) or a system outage (failure of a software/hardware network used for PNR data transmission), the operating carrier must notify the PIU-NL immediately.

ebMS is an OASIS Open Standard based on XML. It is used by the Dutch government for system-to-system information exchange. The protocol implements key aspects for information exchange between organizations:

- Reliable messaging (guaranteed delivery, once and only once).
- Default support for end-to-end security (both non-repudiation and encryption).
- Multi-hop across transparent intermediaries. Connecting via intermediaries eliminates the need for point-to-point connections.
- Exchange based on contract (Collaborative Protocol Agreement).





Dear Sir / Madam,

In May 2016 the European Parliament and Council have adopted Directive (EU) 2016/681 (full text available via <http://eur-lex.europa.eu>). The objectives of this Directive are, inter alia, to ensure security, to protect the life and safety of persons, and to create a legal framework for the protection of PNR data with regard to their processing by competent authorities. Member States are obliged to bring into force the laws, regulations and administrative provisions necessary to comply with this Directive by 24 May 2018.

The Netherlands aims at an earlier transposition date in the second half of 2017. It is therefore also the objective to have a national Passenger Information Unit (the "PIU-NL") operational at that date. Air carriers will then, pursuant to the Act transposing the PNR Directive, be legally required to transmit PNR data (including API data, as far as collected) to the PIU-NL.

About the PIU-NL

With the entry into force of the aforementioned Act, the PIU-NL will collect PNR data from the air carriers and will store, process and transfer said data or the result of processing PNR data to a specified list of competent authorities. The PIU-NL will also exchange both PNR data and the results of processing PNR data with the PIUs of other Member States and with Europol as demanded by the Directive.


The PNR data provided by the air carriers to the PIU-NL shall be depersonalized six months after the transfer through masking out the data elements which could serve to identify directly the passenger to whom the PNR data relate. The data will be deleted permanently after a period of five years.

The processing of sensitive data revealing a person's race or ethnic origin, political opinions, religion or philosophical beliefs, trade union membership, health, sexual life or sexual orientation is prohibited. In the event that PNR data revealing such information are received by the PIU-NL, they shall be deleted immediately.



Legal basis



The legal basis for requesting PNR data from the air carriers by the PIU-NL is the EU PNR directive 2016/681 and Dutch national law.

The full text of the Directive (in multiple languages) may be found here: <http://eur-lex.europa.eu/legal-content/EN/TXT/?uri=CELEX:32016L0681>.

Pursuant to their respective legal mandates, the Customs Administration of The Netherlands and the Royal Netherlands Marechaussee may also request PNR or API data from air carriers. In executing a request from the public prosecutor, competent authorities such as the National Police may also directly request passenger data from air carriers.



Obligations of air carriers



Air carriers shall send PNR (including API as far as collected) to the PIU-NL for all flights to and from the Netherlands (including stop-overs and/or transfers).

Where a flight is code shared the obligation to transfer the PNR data of all passengers on the flight is on the air carrier that operates the flight.


Air carriers shall transmit the required data both before the scheduled flight departure time as well as immediately after flight closure. Failure to comply with these requirements may lead to sanctions.

Transmission of PNR (Scenario 1)


Scenario 1 – Integrated RES & DCS





Transmission of PNR (Scenario 2)


Scenario 2 – Separate RES & DCS


Scenario 3 – Separate RES & Multiple DCS
